SUMMARY/DISCUSSION:

Meals on Wheels of the Salinas Valley (MOWSV) improves the health and well-being of seniors who cannot shop or cook for themselves by delivering nutritious meals to their homes. This helps seniors to age in place and be as independent as possible.

This Agreement was awarded to MOWSV through a formal Request For Proposal (RFP #10785) process in April 2021 by the Area Agency on Aging (AAA).

OTHER AGENCY INVOLVEMENT:

The Auditor-Controller and Purchasing has reviewed and approved this Agreement. County Counsel has approved the Agreement as to form.

FINANCING:

Funding is provided by the Federal Older Americans Act. Sufficient appropriations and estimated revenues for SOC010 are included in the FY 2021-22 Recommended Budget.
