SUMMARY/DISCUSSION:

The Law Office of Kelly S. Wachs, P.C, assists the County of Monterey in navigating the complex employment -based immigration process to accomplish its visa goals. Located in Aptos, California, the law firm provides County departments with obtaining for its employees temporary work visas or visas for permanent residence in the United States. IT seeks the law firm's assistance with H-1B visas and EB visas for permanent residence.

OTHER AGENCY INVOLVEMENT:

County Counsel has reviewed and approved this Agreement as to legal form.

FINANCING:

The cost for this agreement is \$30,000, of which \$30,000 is included in the Approved Budget for the Information Technology Department, ITD 1930, Appropriations Unit INF002, for Fiscal Year 2021-2022. Amounts for Fiscal Year 2022-2023 will be included in that budget as appropriate. There is no impact to the General Fund.
