SUMMARY/ DISCUSSION:

This software maintenance and support software Agreement with Democracy Live, Inc. provides ADA compliant services for the delivery of electronic ballots and hosting of an accessible voter guide. Democracy

Live, Inc. has provided these services successfully for the past five years. The proposed Agreement establishes continued services to cover annual license renewal, maintenance, support, web hosting and ballot delivery.

OTHER AGENCY INVOLVEMENT:

The offices of the County Counsel and Auditor-Controller have reviewed and approved the Agreement as to form/legality and fiscal provisions, respectively.

FINANCING:
