#### SUMMARY/DISCUSSION:

Natividad operates the D'Arrigo Family Specialty Services Outpatient Clinic offering over 15 different specialty care services including pediatric cardiology. Natividad wishes to amend the agreement with UCSF, for which Emilio Quezada, M.D., a board certified pediatric cardiologist, provides outpatient specialty care at least one day per week, so that Dr. Quezada can continue to provide these services without interruption. Natividad has obtained an independent opinion of fair market value supporting the payment terms of this Agreement.

#### OTHER AGENCY INVOLVEMENT:

County Counsel has reviewed and approved this amendment as to legal form. Auditor-Controller has reviewed and approved this Agreement as to fiscal provisions. The amendment was not placed on Natividad's Finance Committee or Board of Trustees agendas in order to ensure compliance with conflict of interest laws.

#### FINANCING:

There is no cost to this amendment. The total not to exceed amount of the Agreement is \$500,000 for the period January 1, 2018 to December 31, 2023 (72 months). \$150,000 is included in the Fiscal Year 2021/2022 Adopted Budget. There is no impact to the General Fund.

### BOARD OF SUPERVISORS STRATEGIC INITIATIVES:

The services rendered in this agreement provide Natividad with the additional support it needs in order to provide reliable and high quality patient care which improves the health and quality of life for patients and their families and allows Monterey County children and their families to remain closer to home for specialized pediatric care.
