RECOMMENDATION:

It is recommended that the Board of Supervisors:

a. Approve and authorize the Director or Assistant Director of the Department of Social Services to sign Amendment No. 2 to Agreement A-15319 with Central Coast Center for Independent Living to provide program housing search, placement support, and rental subsidies for participants of the Housing and Disability Advocacy Program, adding \$199,899 for a revised total contract amount of \$1,452,222; and
b. Authorize the Director or Assistant Director of the Department of Social Services to sign up to three (3) amendments to this Agreement where the total amendments do not exceed 10% (\$145,222) of the revised contract total and do not significantly change the scope of work.

SUMMARY/DISCUSSION:

This amendment adds funds reallocated to Monterey County by the California Department of Social Services to the existing contract with Central Coast Center for Independent Living (CCCIL) for Housing and Disability Advocacy Program (HDAP) services. The program provides housing search, housing placement support, and rental subsidies for adults, youth, and families who are experiencing homelessness or are at risk of homelessness,

may be disabled, are not receiving Social Security benefits or Cash Assistance Program for Immigrants (CAPI) benefits and wish to file or have already filed for these benefits.

OTHER AGENCY INVOLVEMENT:

The Auditor Controller and Purchasing have reviewed and approved this Agreement. County Counsel has approved the Agreement as to form.

FINANCING:

This is reallocated funding that is provided by the California Department of Social Services and local match dollars from CCCIL in the amount of \$199,899, with no County General Fund contribution required. This reallocation has a dollar-for-dollar matching requirement. There are sufficient appropriations and estimated revenues in the 001-5010-SOC005 FY 2021-22 Adopted Budget and FY 2022-23 Requested Budget.

This Agreement correlates to the Health & Human Services Strategic Initiative adopted by the Board of Supervisors by working toward the goals of improving the health and quality of life outcomes for HDAP participants.
