# SUMMARY/DISCUSSION:

MCCAP is a publicly operated Community Action Agency supported by the Monterey County Department of Social Services. MCCAP is committed to reducing poverty in the community by funding a network of local providers who specialize in addressing specific barriers to achieving self-sufficiency. MCCAP's overall mission

is to develop, maintain, and evaluate community services that empower individuals and families living at or below the federal poverty limit to improve their quality of life.

The purpose of the MOU is to establish a linkage between MCCAP and the Center for Employment Training to facilitate coordination and collaboration and leverage each respective agency's service delivery strengths to assist with employment training and placement for individuals served by MCCAP and/or local service providers.
