- a. Accept a \$20,000 Grant Award from Central California Alliance for Health (CCAH) Equipment Program in support of the purchase of equipment to expand Monterey County's capacity to serve Medi-Cal members through the Nurse Family Partnership Program in the County of Monterey (County); and
- b. Approve and authorize the Director of Health or Assistant Director of Health to execute a Medi-Cal Capacity Grant Agreement ("Agreement"), Grant number 1116-MCHD-PH-E1 between (CCAH), in the amount up to \$20,000, for equipment to expand the County's capacity to serve Medi-Cal members through the Nurse Family Partnership Program, effective on the date of execution by County and terminating no earlier than one year after the date of the last payment made to the County.

RECOMMENDATION:

It is recommended that the Board of Supervisors:

- a. Accept a \$20,000 Grant Award from Central California Alliance for Health (CCAH) Equipment Program in support of the purchase of equipment to expand Monterey County's capacity to serve Medi-Cal members through the Nurse Family Partnership Program in the County of Monterey (County); and
- b. Approve and authorize the Director of Health or Assistant Director of Health to execute a Medi-Cal Capacity Grant Agreement ("Agreement"), Grant number 1116-MCHD-PH-E1 between (CCAH), in the amount up to \$20,000, for equipment to expand the County's capacity to serve Medi-Cal members through the Nurse Family Partnership Program, effective on the date of execution by County and terminating no earlier than one year after the date of the last payment made to the County.

SUMMARY/DISCUSSION:

Central California Alliance for Health (CCAH) established the Medi-Cal Capacity Grant Program to support health care providers and community organizations whose efforts help to advance the mission of CCAH, which is to provide timely access to quality health care services and to increase Medi-Cal capacity in their service area. In February of 2017, the Director of Health notified the Board of Supervisors and the County Administrative Officer of the intent to apply for grants for the Nurse Family Partnership. NFP is an evidence based home visitation program that has been proven to improve prenatal health, reduce childhood injuries, abuse and neglect, in increase maternal employment. The grant amount of \$20,000 would be used to support the purchase of medical supplies and equipment for the Nurse Family Partnership Program. In March of 2017, Monterey County Health Department was notified by CCAH that the grant request had been approved in the amount of \$20,000 for the purchase of medical supplies and equipment to support the Nurse Family Partnership Program.

Approval of the recommended action will allow the Monterey County Health Department's Public Health Bureau to receive the benefit of the CCAH Grant Award and continue to support efforts to provide higher quality care and to reduce health care costs.

This work supports the Monterey County Health Department 2011-2015 strategic plan initiatives: 1) Empower the community to improve health through programs, policies, and activities; and 2) Enhance community health and safety by emphasizing prevention. It also supports one of the ten essential public health services, specifically: 9) Evaluate effectiveness, accessibility, and quality of personal and population-based health

services.

OTHER AGENCY INVOLVEMENT:

County Counsel, Auditor-Controller, and Risk Management have reviewed and approved the Agreement.

FINANCING:

The grant amount of \$20,000 will be used to support the purchase of medical supplies and equipment for the Nurse Family Partnership Program. There are sufficient appropriations included in the Health Department's (HEA003-8124) Requested Budget for FY 2017-18.
