Approve and authorize the Director of Health or Assistant Director of Health to execute Amendment No. 6 to Mental Health Services Agreement A-12779 with Door to Hope to extend the term for one (1) additional Fiscal Year (FY) for a new term of July 1, 2015 through June 30, 2021 and revise the total Agreement amount from \$19,596,591 to \$21,896,591 which represents an increase of \$2,300,000 for FY 2020-21. RECOMMENDATION:

It is recommended that the Board of Supervisors:

Approve and authorize the Director of Health or Assistant Director of Health to execute Amendment No. 6 to Mental Health Services Agreement A-12779 with Door to Hope to extend the term for one (1) additional Fiscal Year (FY) for a new term of July 1, 2015 through June 30, 2021 and revise the total Agreement amount from \$19,596,591 to \$21,896,591 which represents an increase of \$2,300,000 for FY 2020-21.

SUMMARY/DISCUSSION:

Door to Hope provides mental health rehabilitation services for children, youth, young adults, and their families through the following programs: Integrated Co-Occurring Treatment; Monterey County Screening Team for Assessment, Referral and Treatment; and Santa Lucia. The goal of each program is to improve the child/youth/young adult's mental health, functioning and well-being, and improve their family/caregiver's parenting skills and ability to meet the developmental needs of their children. This Amendment modifies the Exhibits A: Program Description; B:Payment and Billing Provisions; G: Behavioral Health Cost Reimbursement Invoice; and H: Budget and Expenditure Report to reflect the continuation of funding for the above-listed programs through June 30, 2021.

This Agreement contains the County's standard 30-day "no cause" provision (Section IV.B.) and a defunding provision (Section IV.D.), which provides the County the ability to amend or terminate the Agreement in the event of a reduction and/or termination of funding.

This work supports the Monterey County Health Department 2018-2022 Strategic Plan initiative: 3. Ensure access to culturally and linguistically appropriate, customer-friendly, quality health services. It also supports one or more of the ten essential public health services, specifically:

7. Link people to needed personal health services and assure the provisions of health care when otherwise unavailable.

OTHER AGENCY INVOLVEMENT:

County Counsel-Risk Management and Auditor-Controller have reviewed and approved this Amendment No. 6 as to legal form and fiscal provisions, respectively.

FINANCING:

This Amendment No. 6 is funded by Federal Financial Participation (44%), EPSDT (32%), Mental Health Services Act Funds (23%), and Department of Social Services (1%) revenues. The funds for FY 2020-21 are included in the Health Department's Behavioral Health Bureau (HEA012, Unit 8410) FY 2020-21 Adopted Budget.
