Adopt a resolution commending Salinas Firefighter **Captain Frankie Rodriguez** upon his retirement after 27 years of public service with the City of Salinas.

WHEREAS, On October 19, 1998, Probationary **Captain Frankie Rodriguez** proudly joined the Salinas Fire Department, beginning a fire service career that would span 27 years of dedicated service to the City of Salinas and its residents; and

WHEREAS, Through unwavering commitment, professionalism, and hard work, **Captain Frankie Rodriguez** forged himself into a firefighter and leader trusted and respected by peers, supervisors, and the community alike; and

WHEREAS, **Captain Frankie Rodriguez** was among the first group of Fire Engineers promoted when the rank was officially adopted by the Salinas Fire Department, demonstrating adaptability and excellence during a pivotal time in the department's history; and

WHEREAS, **Captain Frankie Rodriguez** as a dedicated mentor, set the standard for leadership and professionalism, going the extra ten miles to ensure that his probationary firefighters were prepared, confident, and ready for the demanding career ahead of them; and

WHEREAS, **Captain Frankie Rodriguez** is a friend like no other, one who checks in, shows up, and will drop whatever he is doing to help in any way possible, anywhere and at any time; and

WHEREAS, El Rancho Rodriguez, the home of **Captain Rodriguez**, has been the backdrop for countless off-duty gatherings that celebrated the brotherhood and family of the Salinas Fire Department, including Easters, retirements, birthdays, Fourth of July celebrations, and any occasion that brought people together.
