Adopted Resolution No. 18-295 to declare a shelter crisis within unincorporated areas of Monterey County, as required by the Governor and Legislature for local governments seeking an allocation of funding from the Homeless Emergency Aid Program (HEAP) as part of SB 850 and the 2018-19 Budget Act (Chapter 48, Statutes of 2018); and authorized the Departments of Monterey County to collaborate with the Continuum of Care to work with partners to apply and receive funding through HEAP to address urgent homeless needs in Monterey County; and authorized county staff to apply for all available Homeless Emergency Aid Program grant funds for homeless shelter operations and construction, homeless projects, and/or homeless services.

**Resolution No. 18-295**

RESOLUTION OF Monterey County Board of Supervisors of the COUNTY OF MONTEREY, STATE OF CALIFORNIA declaring a shelter crisis pursuant to SB 850 (Chapter 48, Statutes of 2018 and Government Code § 8698.2).

The County of Monterey Board of Supervisors Finds:

**WHEREAS**, California's Governor Edmund G. Brown, Jr. and the members of the California Legislature have recognized the urgent and immediate need for funding at the local level to combat homelessness;

**WHEREAS**, The Governor and Legislature have provided funding to local governments under the Homeless Emergency Aid Program as part of SB 850 and the 2018-19 Budget Act (Chapter 48, Statutes of 2018);

**WHEREAS**, The Governor and Legislature require jurisdictions seeking an allocation through the Homeless Emergency Aid Program to declare a Shelter Crisis pursuant to Government Code §8698.2;

**WHEREAS**, the County of Monterey has developed a homelessness plan and undertaken multiple efforts at the local level to combat homelessness;

**WHEREAS**, the County of Monterey finds that 419 persons within the unincorporated areas of Monterey County are homeless and living without shelter;

**WHEREAS**, the County of Monterey finds that 2,837 persons within all incorporated and unincorporated areas of Monterey County are homeless and living without shelter;

**WHEREAS**, the County of Monterey finds that the number of homeless is significant, and these persons are without the ability to obtain shelter;

**WHEREAS**, the County of Monterey finds that the health and safety of unsheltered persons in the unincorporated areas of Monterey County are threatened by a lack of shelter;

**WHEREAS**, the County of Monterey affirms the County's commitment to combatting homelessness and creating or augmenting a continuum of shelter and service options for those living without shelter in our communities;

**NOW, THEREFORE, BE IT RESOLVED BY** the Board of Supervisors of the County of Monterey, CALIFORNIA that a shelter crisis pursuant to Government Code §8698.2 exists in the County of Monterey, and authorizes the County's participation in the Homeless Emergency Aid Program.
