AMENDMENT #1 TO AGREEMENT A-16928 BY AND BETWEEN COUNTY OF MONTEREY & MAGNET FORENSICS

THIS AMENDMENT is made to the AGREEMENT A-16928 for software subscription and license for the Monterey County Sheriff's Office, by and between **MAGNET FORENSICS**, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and CONTRACTOR originally entered into this Agreement on July 1, 2024, for \$33,105 with a term ending date of June 30, 2025; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT by extending the agreement one (1) year with a new term ending date of June 30, 2026 and adding \$34,760 for a new not to exceed total of \$67,865.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. "PAYMENT PROVISIONS" Invoice will be sent out each fiscal year to 230-sofiscal@countyofmonterey.gov :
 - a. Fiscal Year July 1, 2025 to June 30, 2026 - \$34,760
 - i. Item – GKL-ONF-AD – GrayKey License – Advanced, Unlimited Consent and BFU Extractions. 125 AFU, Instant Unlock or Brute Force Advanced actions. Action Credits Included: 125, Excursion Credits Included: 2
2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
3. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the County on July 1, 2024.
