

**AMENDMENT NO. 2
TO SERVICES AGREEMENT
BETWEEN EXPERIAN HEALTH, INC. AND
THE COUNTY OF MONTEREY ON BEHALF OF NATIVIDAD MEDICAL CENTER
FOR
MEDITRACK ENTERPRISE FOR ACCESS TO MEDICARE DIRECT DATA ENTRY ("DDE")
SCREENS SERVICES**

This Amendment No. 2 to the Services Agreement ("Agreement") which was effective on July 1, 2021 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and Experian Health, Inc. ("CONTRACTOR"); **From this point forward, the party referenced previously as "NMC" shall be referenced as "COUNTY" and collectively, COUNTY and CONTRACTOR are referred to as the "Parties" to this Agreement, with respect to the following:**

RECITALS

WHEREAS, COUNTY and CONTRACTOR had previously entered into an Agreement for Services (hereinafter "Agreement") on July 1, 2021 to provide Meditrack Enterprise for access to Medicare DDE screens services for Natividad Medical Center with a three (3) year term (July 1, 2021 through June 30, 2024) and a total Agreement amount not to exceed \$450,000; and

WHEREAS, the Agreement expired on June 30, 2024; and

WHEREAS, the Parties renewed and amended the Agreement via Renewal and Amendment No. 1 retroactive to July 1, 2024, to extend the term for an additional two (2) year period through June 30, 2026 for a revised full Agreement term of July 1, 2021 through June 30, 2026 to allow for continued need of CONTRACTOR's services with no changes to the original scope of work and to increase the amount payable by an additional \$45,000 for a revised total Agreement amount not to exceed \$495,000; and

WHEREAS, COUNTY and CONTRACTOR currently wish to amend the Agreement via Amendment No. 2 to increase the amount payable by an additional \$300,000 for a revised total Agreement amount not to exceed \$795,000 with no changes to the scope of work or to the term of Agreement (July 1, 2021 through June 30, 2026).

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement and in Renewal and Amendment No. 1 incorporated herein by this reference, except as specifically set forth below.

1. **Section 2 / Paragraph titled, "PAYMENTS BY COUNTY" shall be amended to the following:**

"COUNTY shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by COUNTY to CONTRACTOR shall not exceed the sum of \$795,000."

2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement and in Renewal and Amendment No. 1.
3. A copy of this Amendment No. 2 shall be attached to the Agreement.
4. This Amendment No. 2 is effective when signed by both Parties.
