WHEREAS, to ensure fiscal compliance, DEM requests the Board of Supervisors authorize and direct the Auditor Controller's Office to decrease DEM's appropriations budget (001-1040-8588-DEM001) by the advance of \$1,187,500 and return funds to the Strategic Reserve (BSA 001-3111).
