Amendment #2 to Agreement #A-15099
Chmura Economics & Analytics

This Amendment #2 is made and entered into by and between the County of Monterey, a political subdivision of the State of California, (hereinafter “COUNTY”), and Chmura Economics & Analytics (hereinafter “CONTRACTOR”).

WHEREAS, COUNTY and CONTRACTOR entered into an agreement for a subscription license to utilize workforce and economic management tools in the amount of \$19,031 for the period of February 1, 2021 to January 31, 2022 (hereinafter “Original Agreement”).

WHEREAS, the parties amended the Agreement via Amendment #1 to extend the term to January 31, 2025 and add \$58,806 for a new contract total of \$77,837.

WHEREAS, the parties wish to amend the Agreement via Amendment #2 to **add \$20,405.68** for a **new contract amount of \$98,242.68** and **extend** the term through **January 31, 2026**.

AGREEMENT

NOW THEREFORE, the parties agree to amend the Agreement as follows:

This Agreement is hereby amended on the terms and conditions as set forth in the original Agreement and in Amendment #2 incorporated herein by this reference, except as specifically set forth below.

1. **Page 1, Paragraph 1** is hereby amended and reads as follows:

“This Subscription Agreement (this Agreement”) is effective as of February 1, 2021 (the “Effective Date”), through **January 31, 2026** and is made by and between Chmura Economics & Analytics, LLC, a Virginia limited liability company located at 1309 East Cary Street, Richmond VA 23219 (“Chmura”) and Monterey County Department of Social Services located at 1000 S. Main St., Salinas CA 93901 (“Client”).

2. **“Second Amendment to the JOBSEQ”** incorporates the additional annual periods and the **new annual license fee of \$20,405.68** for a **new contract total of \$98,242.68**.

3. Except as provided herein, all remaining terms, conditions and provisions of the original Agreement are unchanged and unaffected by this Amendment #2 and shall continue in full force and effect as set forth in the original Agreement.

4. A copy of this Amendment #2 shall be attached to the Original Agreement.

SECOND AMENDMENT TO THE

JOBSEQ® SUBSCRIPTION AGREEMENT BETWEEN
MONTEREY COUNTY DEPARTMENT OF SOCIAL SERVICES AND
CHMURA ECONOMICS & ANALYTICS, LLC

This Second Amendment ("Amendment"), effective upon the date of final signature below ("Effective Date"), is between Monterey County Department of Social Services ("Client"), a political subdivision of the State of California, and Chmura Economics & Analytics, LLC ("Chmura"). This document amends the JobsEQ® Subscription Agreement dated 2021-02-01 (the "Agreement"). Client and Chmura agree as follows:

The Agreement is amended, as of the Second Amendment Effective Date, by revising said agreement as follows:
