

**AMENDMENT NO. 1
TO SERVICES AGREEMENT
BETWEEN THYSSENKRUPP ELEVATOR CORP. AND
NATIVIDAD MEDICAL CENTER
FOR
ELEVATOR MAINTENANCE AND REPAIR SERVICES**

This Amendment No. 1 to the Services Agreement ("Agreement") which was effective on January 1, 2015 is entered into by and between the County of Monterey (hereinafter "County"), on behalf of Natividad Medical Center (hereinafter "NMC"), and ThyssenKrupp Elevator Corp.(hereinafter "CONTRACTOR"); (collectively, the County, NMC and CONTRACTOR are referred to as the "Parties"), with respect to the following:

RECITALS

WHEREAS, the Agreement was executed for CONTRACTOR to provide Elevator Maintenance and Repair Services with a term January 1, 2015 through December 31, 2019 and a total Agreement amount not to exceed \$307,862; and

WHEREAS, the Agreement was increased per Board Order A-14186, adding \$385,000 for a revised total of \$692,862: and

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement to extend it for an additional one (1) year period through December 31, 2020, with no change to the original scope of work or total agreement amount.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby amended on the terms and conditions as set forth in the Agreement, except as specifically set forth below.

- 1.Paragraph titled "TERM OF AGREEMENT", first sentence shall be amended to the following:
"The term of this Agreement is from January 1, 2015 through December 31, 2020 unless sooner terminated pursuant to the terms of this Agreement."
2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect.
3. A copy of this Amendment No. 1 shall be attached to the Original Agreement.
4. This Amendment No. 1 shall be effective when January 1, 2020.
