## Requested Rate Proposal

#### Proposed rates for 2024:

- 8.72% increase for the commercial and residential customers within the jurisdiction of the Monterey Regional Waste Management District (MRWMD)
- 7.56% increase for the commercial and residential customers within the jurisdiction of the Salinas Valley Solid Waste Authority (SVSWA)

# Rate Adjustment Examples

Adjustment	Service Level	Current Rate	New Rate	Difference
MRWMD 8.72%	Residential: 35 gal cart	\$42.81	\$45.63	\$2.82 per month (\$33.84 per year)
	Commercial: 3 Cubic Yards Once per week	\$382.44	\$415.80	\$33.36 per month (\$400.32 per year)
SVSWA 7.56%	Residential: 35 gal cart	\$43.53	\$46.82	\$2.71 per month (\$32.52 per year)
	Commercial: 3 Cubic Yards Once per week	\$572.34	\$615.60	\$43.26 per month (\$519.12 per year)
