

Amendment No. 1
To Memorandum of Understanding by and between
The County of Monterey and
Monterey County Sexual Assault Response Team Steering Committee

This **Amendment No. 1** ("Amendment") to the **Memorandum of Understanding** (MOU) is made by and between the **County of Monterey**, a political subdivision of the State of California ("COUNTY"), and **Monterey County Sexual Assault Response Team Steering Committee** ("AGENCY") with respect to the following.

- A. On November 28, 2022, COUNTY and AGENCY entered into an MOU for the term November 1, 2022, through October 31, 2025, for the provision of coordinating community response to the needs of survivors of sexual assault.
- B. COUNTY and AGENCY wish to amend the MOU to extend the term for **three (3) additional years**, for an aggregate term of **November 1, 2022, through October 31, 2028**.
- C. COUNTY and AGENCY wish to amend **Agreement A-16089** to increase the amount of the Agreement by One Hundred Twenty Thousand Dollars (\$120,000.00) for a total aggregated amount not to exceed Two Hundred Eighty Thousand Dollars (\$280,000.00); where the parties agree that the annual payment of \$20,000 from Montage Health Community Hospital of the Monterey Peninsula (CHOMP) and \$20,000 from Salinas Valley Health (SVH) to the COUNTY Health Department shall continue under the extended term with no changes to the services outlined in the original MOU.

The COUNTY and AGENCY hereby agree as follows:

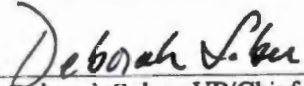
1. **Section 2 Financial Commitment** of the MOU is amended by deleting subdivisions b. and c. in their entirety and replacing with the following provisions:
 - b. Montage Health CHOMP agrees to provide financial assistance in the amount of Twenty Thousand Dollars (\$20,000.00) to be paid annually to the COUNTY to support the financial viability of the SART Program. The COUNTY shall invoice Montage Health CHOMP for the first quarter of the COUNTY's fiscal year commencing July 1, 2025, and full payment of the \$20,000.00 contribution amount shall be made to the COUNTY within forty (40) days of the invoice date, for a total amount of Sixty Thousand Dollars (\$60,000.00) for the additional three (3) years of service added by this Amendment No. 1, for a total MOU amount not to exceed One Hundred Forty Thousand Dollars (\$140,000.00).
 - c. Salinas Valley Health agrees to provide financial assistance in the amount of Twenty Thousand Dollars (\$20,000.00) to be paid annually to the COUNTY to support the financial viability of the SART Program. The COUNTY shall invoice SVH for the first quarter of the COUNTY's fiscal year commencing July 1, 2025, and full payment of the \$20,000 contribution amount shall be made to the COUNTY within forty (40) days of the invoice date, for a total amount of Sixty Thousand Dollars (\$60,000.00) for the additional three (3) years of service added by this Amendment No. 1, for a total MOU amount not to exceed One Hundred Forty Thousand Dollars (\$140,000.00).
2. **Section 3 Term of MOU** is amended by deleting "It is agreed that this MOU will be binding upon all signatories until October 31, 2025, or amend the MOU." and replacing it with **"It is agreed that this MOU will be binding upon all signatories until October 31, 2028. This MOU may be amended or modified only by an instrument in writing signed by all signatories."**
3. Except as provided in this Amendment, all remaining terms, conditions, and provisions of the MOU are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the MOU.
4. A copy of this Amendment No. 1 shall be attached to the original Agreement executed by the County on November 28, 2022.

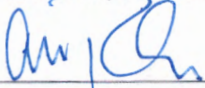

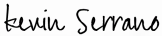
