

**AMENDMENT #3  
TO AGREEMENT BETWEEN  
COUNTY OF MONTEREY AND  
KENNEDY/JENKS CONSULTANTS**

**THIS AMENDMENT** is made to the AGREEMENT, by and between **Kennedy/Jenks Consultants**, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY", for the providing of environmental consulting services and monitoring and reporting of groundwater for the Lake San Antonio Resort/Marina site (Site) located in Monterey County, California.

**WHEREAS**, the COUNTY and CONTRACTOR previously entered into the original AGREEMENT on March 30, 2016; and

**WHEREAS**, the COUNTY and CONTRACTOR amended the AGREEMENT, to increase the amount of the AGREEMENT by \$21,000, from \$36,000 to \$57,000, and extend the term by two years through February 28, 2019.

**WHEREAS**, the COUNTY and CONTRACTOR amended the AGREEMENT, to increase the amount of the AGREEMENT by \$13,500, from \$57,000 to \$70,500.

**WHEREAS**, the COUNTY and CONTRACTOR hereby wish to amend the AGREEMENT, to increase the amount of the AGREEMENT by \$8,000, from \$70,500 to **\$78,500**.

**NOW THEREFORE**, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Section 2. "PAYMENTS BY COUNTY" shall be amended by removing, "The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$70,500." and replacing it with: "**The total amount payable by COUNTY to CONTRACTOR under this Agreement shall not exceed the sum of \$78,500**".
2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect, as set forth in the AGREEMENT.
3. A copy of the AMENDMENT 3 shall be attached to the original AGREEMENT executed by the COUNTY on March 30, 2016.
