ADOPT A RESOLUTION HONORING MONTEREY POLICE CHIEF DAVID J. HOBER ON THE OCCASION OF HIS RETIREMENT

WHEREAS, Chief David J. Hober has served the City of Monterey with honor and distinction, beginning his tenure as Assistant Chief of Police in February 2015 and being appointed as the twenty-second Chief of Police on July 15, 2015; and

WHEREAS, Chief Hober's exemplary law enforcement career began in 1988 with the San Jose Police Department, where he progressed through the ranks as officer, sergeant, lieutenant, captain, and deputy chief, and also served as a Special Agent with the Federal Bureau of Investigation; and

WHEREAS, during his tenure as Monterey's Police Chief, Chief Hober led the department with dedication and vision through unprecedented challenges including the COVID-19 pandemic and the 2020 protests, ensuring continued delivery of essential public safety services while prioritizing the health and well-being of officers and community members; and

WHEREAS, Chief Hober implemented transformative training initiatives such as Integrating Communications, Assessment and Tactics (ICAT), Crisis Intervention Training (CIT), and Active Shooter Response protocols, improving officer preparedness and community-focused policing; and

WHEREAS, under Chief Hober's leadership, the department adopted key technological innovations including the deployment of Axon body-worn cameras, Automated License Plate Readers, and modernization of the department's Records and Jail Management Systems; and

WHEREAS, Chief Hober launched the Multi-Disciplinary Outreach Team (MDOT), a pioneering collaboration between law enforcement and social service professionals that addressed the needs of unhoused individuals, strengthened community trust, and served as a model of compassionate policing; and

WHEREAS, Chief Hober is recognized throughout the Monterey Peninsula and beyond for his professionalism, integrity, collaborative leadership, and unwavering commitment to public service.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Monterey does hereby commend and congratulate Chief David J. Hober upon his retirement, expresses its deepest appreciation for his outstanding service to the City of Monterey and the broader community, and extends its best wishes for continued success and fulfillment in all future endeavors.
