WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to correct the total contract amount to reflect the amount of \$156,938, the amount approved by the Board on March 28, 2023, plus an additional \$.67, for a revised total contract amount of \$156,938.67.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 2.0, "Payment Provisions", shall be amended by removing, "The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of: \$156,393.67", and replacing it with "The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of: \$156,938.67.
- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 3. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the County on March 29, 2023.
