

- No electrical/gas work is included UON
- No temporary or permanent fencing of any kind
- Soils and materials testing
- Not responsible for damage or repair of un-marked utilities
- Permits, fees and/or inspections
- Not responsible contaminated soil removal, disposal or handling
- Unsuitable soils and or dry back of any kind
- Supplying or paying for construction water
- SWWPP monitoring or reporting
- Existing underground utility removal and relocation due to elevation or alignment conflicts with new design.
