#### SUMMARY/DISCUSSION:

The 2024-2025 Monterey County Civil Grand Jury Report titled "Road Safety in Monterey County: Where to report a problem" was issued on April 28, 2025. The Grand Jury requests responses from your Board to Findings F5-F6 and F9, and Recommendations R5-R6 to the road safety in Monterey County report, which are within the County's scope of responsibility. California Penal Code, section 933(c) requires your Board to respond to the Presiding Judge within 90 days.

Recommended response is included in Exhibit A for your Board's consideration. Upon adoption by your Board, the response will be submitted to the Presiding Judge. The response letter is included as Exhibit B.

The draft response was prepared by Public Works Facilities and Parks (PWFP) and submitted to the County Administrative Office for formal submittal to the Board Office.
