WHEREAS, Kimberley Moore has dedicated nearly thirty-six years to the field of Human Resources, including more than thirty years in public service, and has been a valued member of the County of Monterey since October 2001; and

WHEREAS, Kimberley Moore has served as Assistant Director of Human Resources since February 2014, providing steady leadership and continuity under three different Directors of Human Resources, demonstrating professionalism, integrity, and unwavering dedication to the County and its workforce; and

WHEREAS, Kimberley Moore began her Human Resources career with San Francisco French Bread in Castroville, California, from 1989 to 1996, and later joined California State University Monterey Bay as a Recruitment and Compensation Analyst from 1996 to 2001, where she was a founding Human Resources staff member and completed the Exceptional Manager program; and

WHEREAS, throughout her career with the County, Kimberley Moore played an integral role in advancing modernization and efficiency, helping to implement the County's first Enterprise Resource Planning system in 2010 and multiple NEOGOV modules including Insight, OHC, Learn, and Onboard, as well as contributing to the establishment of the Human Resources Department as a stand-alone entity outside of the County Administrative Office; and

WHEREAS, Kimberley Moore continually pursued professional growth, earning credentials through the California State Association of Counties (CSAC) Leadership Program, National Association of Counties (NACo) High Performance Leadership Academy, Intergovernmental Management Training Program, ITIL Foundation in IT Service Management, and other leadership programs; and

WHEREAS, Kimberley Moore's lifelong commitment to public service is matched by her lifelong roots in Monterey County, where she was born and raised on the Monterey Peninsula, attended local schools, and proudly represents a family of Veterans who served at Fort Ord; and

WHEREAS, Kimberley Moore is admired by colleagues for her dedication, compassion, professionalism, consistency, honesty, mentorship, teamwork, and willingness to help, which have left a lasting impact on the organization and those fortunate to have worked alongside her; and

WHEREAS, beyond her professional accomplishments, Kimberley Moore and her husband Frank Johns have shared thirty years of marriage, enjoy playing music together, with Kim being the avid San Francisco 49ers fan, and share their home with their beloved dog, Layla.
