

**AMENDMENT NO. 3
TO SERVICES AGREEMENT
BETWEEN CORTICARE, INC. AND
THE COUNTY OF MONTEREY ON BEHALF OF NATIVIDAD MEDICAL CENTER
FOR
REMOTE EEG MONITORING AND READING**

This Amendment No.3 to the Services Agreement (“Agreement”) which was effective on April 20, 2022 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (“NMC”), and CortiCare, Inc. (“CONTRACTOR”); **From this point forward, the party referenced previously as “NMC” shall be referenced as “COUNTY” and collectively, COUNTY and CONTRACTOR are referred to as the “Parties” to this Agreement, with respect to the following:**

RECITALS

WHEREAS, the Agreement was executed with CortiCare, Inc. for remote EEG monitoring and reading services with a term April 20, 2022 through April 19, 2024 and a total Agreement amount not to exceed \$100,000; and

WHEREAS, COUNTY and CONTRACTOR amended the Agreement via Amendment No. 1 to extend it for an additional one (1) year period through April 19, 2025 for a revised full Agreement term (April 20, 2022 through April 19, 2025), with no changes to the scope of work or billing rates and to add an additional \$100,000 for a revised total Agreement amount not to exceed \$200,000.

WHEREAS, COUNTY and CONTRACTOR amended the Agreement on July 1, 2024 via Amendment No. 2 to extend it for an additional one (1) year period through April 19, 2026, and to add an additional \$250,000 thereby increasing the total Agreement amount to \$450,000; and

WHEREAS, COUNTY and CONTRACTOR currently wish to amend the Agreement via Amendment No. 3 to extend it for an additional one (1) year period through April 19, 2027, and to add an additional \$250,000 thereby increasing the total Agreement amount to \$700,000.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement, Amendment No. 1 and Amendment No. 2 incorporated herein by this reference, except as specifically set forth below.

1. The second sentence of Paragraph titled, “PAYMENTS BY COUNTY” shall be amended to the following:

“The total amount payable by COUNTY to CONTRACTOR under this Agreement shall not exceed the sum of \$700,000.”

2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 3 and shall continue in full force and effect as set forth in the Agreement, Amendment No. 1 and Amendment No. 2.
3. A copy of this Amendment No. 3 shall be attached to the Agreement.

4. This Amendment No. 3 shall be effective April 20, 2026.

IN WITNESS WHEREOF, the Parties hereto are in agreement with this Amendment No. 3 on the basis set forth in this document and have executed this Amendment No. 3 on the day and year set forth herein.
