Mailer was sent out to homes within 300 ft of the proposed project site that included information on the community listening sessions as well as the project fact sheet. (November 3, 2025)

- Area has been a dumping ground
- Asking for respect to this community
- o Build it on Highway 68, Pebble Beach, Fort Ord, or Prunedale
- Build the facility in another county
- Land swap with City of Salinas is an option
- Use old hospital building for this project
- Want to keep this a residential community/neighborhood

Concerns with costs and staffing

- o How much will the county be reimbursed per patient at MHRC?
- Operational costs are high
- Project cost has increased and there is a concern that funds will run out before completion
- o Project cost is high
- Staffing will be an issue with impacted workforce

Concerns with safety

- City and County have destroyed the area
- o Inmates from other counties are released from jail and impact the neighborhood
