

**Amendment No. 1 to Memorandum of Understanding Between
the County of Monterey and The Monterey Peninsula Regional Park
District
(Amendment No. 1 – First Extended Term – April 18, 2026 to April 17,
2027)**

This Amendment No. 1 to the Memorandum of Understanding (“MOU”) between the County of Monterey, a political subdivision of the State of California (hereinafter, “COUNTY”) and the Monterey Peninsula Regional Park District (hereinafter “MPRPD”) is hereby entered into between the COUNTY and MPRPD (collectively, the “parties”) and effective as of the last date opposite the respective signatures below.


WHEREAS, on April 18, 2023, COUNTY Board of Supervisors approved and authorized an MOU between the parties effective April 18, 2023, for an initial term April 18, 2023 – April 17, 2026, for no cost.

WHEREAS, the Board authorized the COUNTY Library Director to execute up to two (2) future year amendments to the MOU that do not significantly alter the scope of work.

WHEREAS, now, the parties desire to amend and extend the Agreement, on the same or similar terms, for an additional one (1) year term of April 18, 2026 through and including April 17, 2027 (hereinafter, “Amendment No. 1 – First Extended Term”).

NOW THEREFORE, the parties agree as follows:

1. The first sentence under the **TERM** provision, “This MOU is in effect **upon signing and will be for a term of three (3) years**” shall be changed to “This MOU is in effect **from April 18, 2026 through April 17, 2027**”
2. The last sentence in the first paragraph under **TERM**, “This MOU may be extended by mutual agreement of the parties on a year-by-year basis” will be removed.
3. An additional provision under **ROLES AND RESPONSIBILITIES** of MPRPD shall be added: “**MPRPD shall obtain and have in place any additional licenses, permits, or permissions required to undertake the above activities.**”
4. An additional provision under **ROLES AND RESPONSIBILITIES** of the MPRPD shall be added: “**Any personally identifiable information collected by MPRPD from the public through participation the activities shall be collected and retained by MPRPD, and not shared with or represented as being collected by or for MCFL.**”
5. The organizations’ appointee contact information for Savannah Peña is to be updated to the title of Environmental Education Supervisor.

This MOU may be executed in two or more counterpart copies, each of which shall be deemed as original and all of which, when taken together, shall constitute one and the same instrument.”
8. If there is any conflict or inconsistency between the provisions of the MOU or its subsequent amendments, the following shall have precedence:
 - Amendment No. 1 over the Agreement.
9. A copy of this Amendment No. 1, shall be attached to the original MOU approved by said Board on **April 18, 2023**.
10. All other terms and conditions in the MOU remain in full force and effect.
11. This Amendment No. 1 shall become effective immediately upon execution of the parties.
