Adopt Resolution Recognizing **Pete Delgado** Upon His Retirement from Salinas Valley Health.

WHEREAS, Pete Delgado earned a Bachelor of Science Degree in Healthcare Administration from the University of Houston, a Master of Science Degree in Hospital Administration from the Texas Women's University, and attended Stanford University's and Harvard University's Senior Executive Program; and

WHEREAS, Pete Delgado has served as the President and Chief Executive Officer of Salinas Valley Health for the last 10 years, which encompasses and acute care public district hospital, 10 urgent care clinics, a group of primary care and specialty physicians and more than 2,400 staff including 322 board-certified physicians; and

WHEREAS, Pete Delgado has previously served in numerous other leadership roles including, Chief Executive Officer and Independent Healthcare Consultant for Delgado and Associates, Executive Vice President and Chief Operating Officer for Santa Rosa Health Care Systems, Chief Operating Officer for RE Thomason Hospital, and Chief Executive Officer for Columbia Valley Regional Medical Center, Kaiser Health Plan & Hospitals in North Bay, Los Angeles County + University of Southern California (LAC+USC) Healthcare Network, and Wilson Memorial Hospital; and

WHEREAS, Pete Delgado is a founding member of the National Forum for Latino Healthcare Executives, which works to increase the representation of Latinos at the executive level of hospitals across the nation; and

WHEREAS, Pete Delgado was named in 2021 a Top Diversity Leader by Modern Healthcare and Citizen of the Year in 2021 by the Salinas Valley Chamber of Commerce; and

WHEREAS, Under Pete Delgado's leadership, Salinas Valley Health achieved the American Nurses Credentialing Center Magnet[®] Recognition in May 2021, which fewer than 10% of hospitals and medical centers nationwide receive this prestigious distinction for nursing excellence; and

WHEREAS, Pete Delgado led Salinas Valley Health to expand their services to the Salinas Valley Health Mobile Clinic, bring state-of-the-art care to residents through South County growing their network of 21,000 patient visits in 2014 to more than half a million today.

NOW, THEREFORE BE IT RESOLVED, that the County of Monterey Board of Supervisors, on behalf of the County and all residents thereof, hereby recognize the exemplary accomplishments, leadership, and service **Pete Delgado** has provided to our communities in the County of Monterey, including his 10 years as the President and Chief Executive Officer of Salinas Valley Health, and wishes him success, good health, and happiness in all future endeavors.
