**DESCRIPTION OF WORK** to be done consists, in general, of providing all labor, materials, tools, appurtenances, and equipment required as well as any other items and details not mentioned above but required by the Contract Documents and as directed by the Assistant Administrator or designee to provide general construction, repair, remodel, and other repetitive related work at NMC. The Scope of Work (SOW) for this contract will be determined by the Detailed SOW issued in connection with individual Job Orders. The SOW for each project will be explained to Contractor at a Joint Scope Meeting.

This Job Order Contract (JOC) is an indefinite quantity contract pursuant to which Contractor will perform a variety of individual projects, consisting of specific construction tasks. County may award up to two (2) individual contracts but reserves the right to reject any and all bids and waive any irregularities in any bid received.
