# **SCHEDULED MATTERS**

1. Appoint the Monterey County Parks Commission Chair and Vice Chair for the 2025 calendar year.

**Action:** During the calendar 2025 District 1 will serve as chair and District 2 will serve as Vice Chair. Commissioner Ellerbee moved to approve, and Commissioner Stracke 2<sup>nd</sup> the motion, the Commission voted unanimously to approve the appointment of Chair and Vice Chair.

- 2. Receive a presentation from Big Sur Land Trust representative Nicole Chrislock on the partnership with the County of Monterey Parks and Lakes Division at the Marks Ranch property within Toro Regional Park.
- 3. Received a presentation from Monterey County Water Resources with a brief background and update on the following Agency projects: Interlake Tunnel, Nacimiento Dam Plunge Pool Project, and San Antonio Dam Spillway Replacement Project.
- 4. Received a report of the Park's volunteer hours and services by park for the period of July 1, 2023, through June 30, 2024.
- 5. Discuss with Chief of Parks Bryan Flores potential County of Monterey Parks and Lakes Division Projects that could be funded with Measure AA revenue.

  Items mentioned included:
- All-inclusive outdoor workout equipment
- Rubberized surface
- Remove & replace playgrounds increase footprint
- Road upgrades
- Amphitheater at North Shore
- Commissioner Sanchez recommended soccer fields, Volleyball courts at the lakes
- Commissioner Stracke recommended Disc Golf at the lakes would be good
- Chief of Parks Bryan Flores mentioned an RC track at lakes, horseshoe pits and possible permeant Disc golf.
- CDFW updates Elk tagging at North Shore LSA about 12 -15 Elk we're tagged. There was trout stocking at the Lake on 12/11/24 4000 lbs. of sterile rainbow trout, 12/18/24 400 lbs. of trophy trout, and 1/13/2025 3000 lbs. of regular & trophy trout were stocked. Unfortunately, on 2/26 the stock was cancelled due to not having the supply of trout.
- Wildflower welcomed 1158 attendees bringing back the event since prior to covid
- Spartan welcomed 7800 participants
- AIDS Life cycle this year was the last year. Event is shutting down.
- Staff is working to bring a Food Truck Night, Concerts, Movies in the Park, and other events.
- Parks RX in July at Toro Park
- Parks Marketing, working on video short of each park, commercials on TV & social media, working with the County Publicity Team.
