### AMENDMENT #1 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY & PEREGRINE TECHNOLOGIES, INC.

---

**THIS AMENDMENT** is made to the AGREEMENT for on-boarding, training and professional services by and between **PEREGRINE TECHNOLOGIES, INC.**, hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “County”.

**WHEREAS**, the County and CONTRACTOR originally entered into this Agreement on November 1, 2024, with a Not to Exceed amount of \$155,000 and a term date ending of October 31, 2025; and

**WHEREAS**, the County and CONTRACTOR wish to amend the AGREEMENT by adding \$155,000 for a new not to exceed total of \$310,000 and extend the agreement by one (1) year with a new term ending date of October 31, 2026, with Amendment #1; and

**NOW THEREFORE**, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Section 2., “PAYMENT PROVISIONS” shall be amended by removing, “*The total amount payable by County to CONTRACTOR under this Agreement is shall not exceed the sum of: \$155,000*”, and replacing it with, “*The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of: \$310,000*”.
2. Section 3., “TERM OF AGREEMENT” shall be amended by removing, “The term of this Agreement is from November 1, 2024 to October 31, 2025”, and replacing it with, “The term of this Agreement is from November 1, 2024 to October 31, 2026,”
3. Exhibit A – Scope of Services/Payment Provision shall be amended by adding A.4 - shall be amended by adding “CONTRACTOR shall pay for the livescan of any additional employee(s) working on MCSO project(s)” (effective November 1, 2025).
4. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
5. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the County on November 1, 2024.
