Adopt Resolution Commending **Captain Joseph Moses** Upon His Retirement from Twenty-Nine Years of Public Service with the Monterey County Sheriff's Office.

WHEREAS, Captain Joseph Moses was born in Brea, California; growing up in Citrus Heights, California and later moving to Monterey County after being hired in 1994; he graduated from Casa Roble High School in 1989; he graduated from California State University, Sacramento in 1994 with a Bachelor of Science in Criminal Justice, and earned a Master of Science in Emergency Services Administration from California State University, Long Beach; he also earned a POST Supervisory and Management Certificate and is a graduate of the Sherman Block Leadership Institute as well as the Senior Management In Policing program at Boston University; and

WHEREAS, Captain Joseph Moses was sworn in by Sheriff Norm Hicks and has served under six Monterey County Sheriffs: Norm Hicks, Gordon Sonne, Mike Kanalakakis, Scott Miller, Steve Bernal, and Tina Nieto; and

WHEREAS, Captain Joseph Moses has demonstrated excellent performance during his tour of duty at the Monterey County Sheriff's Office where he held the positions of Correctional Deputy, Patrol Deputy, Sheriff's Sergeant, Sheriff's Commander, and Sheriff's Captain; he served as COMMET Deputy, Dive Team Deputy, Search and Rescue Deputy Supervisor, and Manager, Special Operations Sergeant and Commander, and Custody Operations Captain to name a few; and

WHEREAS, Captain Joseph Moses touched each facet of the Sheriff's Office throughout his career, specializing in crisis response and multi-agency coordination; developing the volunteer units and community-based organizations into robust assets for Monterey County; and worked as Incident Commander in many local disasters including the Basin Complex and Soberanes fires, culminating in being tasked by California Office of Emergency Services to manage the search for victims of the Camp Fire in Butte County; and

WHEREAS, In the last six years of his career, Captain Joseph Moses was called upon to manage the Custody Operations Bureau and bring his expertise in crisis management to improve the operation of the County Jail; while in this role, he spearheaded many programs and initiatives such as the implementation of the Jail Based Competency Treatment (JBCT) Program, Medication-Assisted Treatment (MAT) Program, and paving the way for the creation of a County Behavioral Health Center.

NOW, THEREFORE BE IT RESOLVED, that the County of Monterey Board of Supervisors, on behalf of the County and all residents thereof, hereby acknowledges, commends, and thanks **Captain Joseph Moses** for his twenty-nine years of exemplary public service to the residents of the County of Monterey, as a valued member of the Monterey County Sheriff's Office.
