Adopt a resolution honoring **Allison Guevara** for her role as a mentor to Centro Binacional para el Desarrollo Indígena Oaxaqueño (CBDIO) on the Salinas Inclusive Economic Development Initiative (SIEDI).

WHEREAS, SIEDI is an important initiative started in 2021 with the support of The James Irvine Foundation and the Community Foundation for Monterey County; and

WHEREAS, SIEDI is funded by a \$3.3 million grant from The James Irvine Foundation in partnership with the Community Foundation for Monterey County to support nonprofits and community groups to influence inclusive recovery and economic development efforts, especially those related to the preservation and creation of quality, family-sustaining jobs in Salinas; and

WHEREAS, SIEDI will increase the number of family-sustaining, good jobs in Salinas and strengthen the Community Foundation for Monterey County's capacity to engage in inclusive economic development efforts; and

WHEREAS, SIEDI has been a place where leaders together explore and understand our current economy and discover how it can be redesigned to benefit more of the families they represent; and

WHEREAS, nonprofits selected to participate in SIEDI were each partnered with an individual mentor; and

WHEREAS, through their dedicated efforts, SIEDI mentors have strengthened the leadership, strategic capacity, and collaboration of local nonprofits; and

WHEREAS, these mentors have guided participating organizations to develop shared strategies, analyze power structures, and elevate community voices—ensuring that inclusive economic development in Salinas is rooted in lived experience and collective vision; and

WHEREAS, the commitment and compassion of SIEDI mentors have left a lasting impact on the Salinas Valley by nurturing leaders who continue to champion dignity, fairness, and economic opportunity for all;

WHEREAS, **Allison Guevara** was selected to be a SIEDI mentor because of her expertise, lived experience and knowledge; and

WHEREAS, **Allison Guevara** was paired with Centro Binacional para el Desarrollo Indígena Oaxaqueño (CBDIO) to serve as their mentor.
