	Project Description:	Combined Development Permit to allow the consolidation of the Pajaro Water System ("PWS"), the Sunny Mesa Water System ("SMWS") and the Springfield Water System ("SWS"), as well as the various water connections in the North of Moss Landing ("NOML") area into a single water system to be owned and operated by the Pajaro Sunny Mesa Community Services District including 1) a Coastal Development Permit and Use Permit for construction of public utilities, infrastructure, pipeline, storage tank, booster pump, and well, 2) Coastal Development Permit for development within 750 feet of known archaeological resources, 3) Coastal Development Permit for development on slopes in excess of 25%, 4) Coastal Development Permit for development within 100 feet of Environmentally Sensitive Habitat Areas (pond, wetland, riparian and habitats of special status species including California Tiger Salamander, California Red- legged Frog, Santa Cruz Long-toed Salamander, Western Burrowing Owl and several others), 5) Coastal Development Permit for development within 150 feet of perennial waterways, 6) Coastal Development Permit for

Additionally, the amount of grading and proximity to sensitive habitat, and archaeological resources, which apparently has not been completely studied or reviewed, not favored. It appeared on its face that project plans are not in final form.		

Moreover, unclear as to whether LAFCO has rendered their approval. The Environmental study has not even been completed. If the actual project changes, does it return to the LUAC and Planning for reconsideration? This project seems premature, and invasive given the aforementioned.
