WHEREAS, Ryan Macoubrie became a member of the fire academy cadre that is credited with successfully graduating its 17 new recruits of Rescue Technicians and is responsible for the refresher training of the department's personnel every year; and

WHEREAS, Ryan Macoubrie is a licensed Unmanned Aerial Systems (UAS) pilot and member of the fledgling drone team; and

WHEREAS, Ryan Macoubrie's accomplishments include, graduating from the Critical Care Paramedic Program, Paramedic and Emergency Medical Servis (EMS), Platoon Training Coordinator (PTC) and Tactical Paramedic with Salinas Police SWAT team; and

WHEREAS, Ryan Macoubrie is a founding member and President of the Salinas Firefighters Foundation that dedicated to inspiring the next generation of public servants in the Salinas Valley, and whose mission it is to give back to the community and its youth.
