## **Resolution No.:**

Adopt a Resolution Commending County Counsel Leslie J. Girard Upon his Retirement After more Than 15 Years in the Office of the County Counsel and 42 Years of Dedicated Public Service.

**WHEREAS, Leslie J. Girard** received a Bachelor of Arts from San Diego State University, and a Juris Doctor degree from Georgetown University Law Center; and

**WHEREAS, Leslie J. Girard** started his law career working in the City Attorney's Office for the City of San Diego; and

**WHEREAS, Leslie J. Girard** while at the City of San Diego served as a Deputy City Attorney for 11 years, working on a variety of matters including civil advisory work, litigation, land use, and other complex cases; and

**WHEREAS, Leslie J. Girard** served as Chief Deputy City Attorney for Legislative and Public Affairs for the City of San Diego for two years and then as the Assistant City Attorney for Special Projects from 1998 through 2003; and

WHEREAS, Leslie J. Girard, as Assistant City Attorney, worked as a principal in the negotiation and implementation of the City's Ballpark and Redevelopment Project, a complex public/private partnership approved by the electorate in 1998 that resulted in the construction of Petco Park, home of the San Diego Padres, and that furthered the revitalization and redevelopment of downtown San Diego; and

**WHEREAS, Leslie J. Girard**, from September of 2003 through 2004, was acting Executive Assistant City Attorney, responsible for the on-going operations of both the Civil and Criminal Divisions of the City Attorney's Office and responsible for a number of other high profile, complex projects and lawsuits running the gamut of municipal law including negotiations with the (then) San Diego Chargers and fiscal matters affecting the City; and

**WHEREAS, Leslie J. Girard**, in 2005, joined the firm McKenna, Long & Aldridge LLP in San Diego working in the Government Affairs practice group; and

**WHEREAS, Leslie J. Girard**, in June of 2008, desired to return to public service and joined the Monterey County Counsel's Office as Assistant County Counsel and then Chief Assistant County Counsel, and, in those capacities assisted the County Counsel in overseeing all operations of the office; and

**WHEREAS, Leslie J. Girard** also advised the Civil Grand Jury, Local Agency Formation Commission of Monterey County, the Monterey Bay Air Resources District, and the Carmel Valley Recreation and Park District; and **WHEREAS, Leslie J. Girard** was appointed County Counsel by the Board of Supervisors in October of 2019, and in that capacity, **Leslie J. Girard** continued to oversee all operations of the office and worked on a variety of other matters including advising the Board of Supervisors and County Administrative Office on labor, water, land use, and numerous other issues; and

**WHEREAS, Leslie J. Girard** was a driving force behind, and has been a primary participant in, the creation of the Joint Powers Authority (the Salinas Valley Basin Groundwater Sustainability Agency) that is the Groundwater Sustainability Agency for the Salinas Valley Groundwater Basin; and

**WHEREAS, Leslie J. Girard** has been married to his wife, Lori, for 31 years and has two sons Nicholas and Leslie; and

**WHEREAS, Leslie J. Girard** has gained a reputation in the Monterey County legal community as a dedicated, knowledgeable and outstanding public entity attorney; and

**WHEREAS**, during the course of his career with the County of Monterey, **Leslie J. Girard** has developed and maintained strong friendships with his colleagues throughout the County family, served as an excellent mentor to younger attorneys while serving as County Counsel, and fostered a collaborative approach to County government; and

**WHEREAS, Leslie J. Girard** has decided to retire and deservedly spend more time with his wife and three golden retrievers, and undertake travel and other activities; and

**WHEREAS, Leslie J. Girard** will be missed by his colleagues not only for his legal skills and leadership, but also for his level-headed demeanor, problem solving abilities, openness, fairness, and witty humor.

**NOW, THEREFORE BE IT RESOLVED,** that the County of Monterey Board of Supervisors, on behalf of the County and all residents thereof, hereby acknowledge, commends, and thanks **Leslie J.
