## **Resolution No.:**

Adopt Resolution Honoring County of Monterey's Director of Human Resources, **Irma Ramirez-Bough** on her Retirement After Twenty-Four Years of Dedicated Service to the County of Monterey.

WHEREAS, Irma Ramirez-Bough is a lifelong resident of Monterey County. She was born in Watsonville and raised in Moss Landing. Her parents, through years of hard work in the agricultural industry, instilled a strong work ethic and the values of loyalty, integrity, and honesty. Irma Ramirez-Bough met her husband of 33 years, Ken Bough and built a family of her own by raising a daughter and son; and

WHEREAS, Irma Ramirez-Bough is a graduate of North Monterey County High School and obtained her Bachelor of Arts degree in Communications from University of the Pacific. Her professional background includes 36 years of public service and experience working as a Human Resources professional. Her career began with the City of Salinas in 1987 and she joined the County of Monterey in 1999. Irma Ramirez-Bough held various Human Resources positions throughout her tenure with County of Monterey; and

WHEREAS, Prior to her appointment as the Director of Human Resources, Irma Ramirez-Bough was the first female Latina to serve as the County's Equal Opportunity Officer under the administrative direction of the County Board of Supervisors, to oversee and manage the Equal Opportunity Office, currently known as the Civil Rights Office; and

WHERAS, During Irma Ramirez-Bough's tenure as the County's Equal Opportunity Officer, she updated the County's Equal Opportunity Plan in 2012 and 2014. Irma Ramirez-Bough was instrumental in updating policies pertaining to employees' rights in the workforce such as the Equal Opportunity and Non-Discrimination Policy, and Sexual Harassment Policy. She also developed and initiated the County's Conflict Resolution Program, among many other accomplishments; and

WHEREAS, Irma Ramirez-Bough has served as the Director of Human Resources for the County of Monterey since July 2016. In this capacity, Irma Ramirez-Bough spearheaded several key accomplishments for the Human Resources Department to include implementing the department's Strategic Plan, participating in Enterprise Resource Plan upgrades, and driving the development of various system trackers in the areas of Recruitment, Exam, Classification and Compensation. Additionally, Irma Ramirez-Bough oversaw the implementation of key policies to include the Compensation Philosophy, Catastrophic Leave Donation Program, Telework, Family and Romantic Relationships at Work, Family Care and Medical Leave to name a few; and

WHEREAS, Irma Ramirez-Bough led the Human Resources Department through two contract negotiation cycles that included establishing policies, standardizing provisions as mutually acceptable by the employee groups and the County; and

WHEREAS, Irma Ramirez-Bough drove the Human Resources Department through unprecedented times. The COVID-19 pandemic caused massive disruptions in our lives, from social distancing and beyond. Despite the challenges, Irma Ramirez-Bough quickly pivoted and adapted to the new reality while prioritizing the wellbeing and safety of the workforce. Besides developing the County's first Emergency Response Manual and COVID-19 Prevention Program, she was also heavily involved in the development of both the COVID exposure application and the COVID self-screening application, which included a COVID vaccination module and the deployment of the Disaster Service Worker program; and

WHEREAS, Irma Ramirez-Bough was vital in hiring an Employee Engagement Manager to manage the County employee engagement efforts which include developing survey tools and analyzing results to identify key opportunities to improve employees' work life experience; and

WHEREAS, Irma Ramirez-Bough's commitment to the human resources profession extends by serving on the Board of the County Personnel Administrators' Association of California (CPAAC) in various capacities to include serving as the current President; and

WHEREAS, Irma Ramirez-Bough will be remembered by her staff and colleagues for her dedication, thoughtfulness, professionalism and gracious leadership and who has significantly contributed to the legacy of the Human Resources Department.

**NOW, THEREFORE, BE IT RESOLVED,** that the Board of Supervisors of the County of Monterey, on behalf of the County, its employees and all its residents hereof, hereby acknowledges, commends, and thanks **Irma Ramirez-Bough** for all her contributions and dedicated service to the County of Monterey.
