**Federal Legislative Update** 

This memo provides a Federal Legislative Update on the items appearing on the agenda for the September 9, 2024, Legislative Committee meeting.

#### 1. Congressional Update

Both the House and Senate have been in recess for the month of August, and are expected to return to DC on September 9<sup>th</sup> and will remain in DC for a 3-week DC work session. Notably, given that this is an election year, both chambers will be in recess again for the month of October and until the week after the election in November. Once they return on November 12, 2024, both chambers are only scheduled for eight legislative weeks before the end of the 118<sup>th</sup> Congress (which will conclude on January 3, 2025). There is a great deal of work to be done this year, including funding the federal government for FY25, with current funding authorization for FY24 set to expire at midnight on September 30, 2024.

#### 2. Budget Update

The House Committee on Appropriations has approved all 12 of the annual appropriations bills for FY25, and the full House has passed five of the 12 so far (Defense, Homeland Security, Interior-Environment, Milcon-VA, and State-Foreign Operations). None of the five bills that have passed the Republican-led House so far are expected to pass in the Democrat-controlled Senate. The Senate Committee on Appropriations has approved all but one of the 12 bills (Homeland Security), but has not yet started floor consideration of any of the bills. Congress is expected to begin working towards a stop-gap funding mechanism called a continuing resolution or CR in September to avoid a government shutdown in October. My working assumption is that Congress will pass a CR that funds the government until after the

election. However, there are rumors that the CR may be scheduled to fund the government until early 2025, and leave the mess to be resolved early in the next Congress.

# 3. Federal Budget Requests, including Community Project Funding Requests Summary

The County submitted a total of nine projects for consideration by the federal delegation for Community Project Funding/Congressionally Directed spending – also called earmarks – for FY25. As I presented in August, only the \$1,105,800 earmark requested by Rep. Lofgren for the Pajaro County Sanitation District (PCSD) Sewer System Improvements project is expected to continue moving forward. At this stage, the PCSD project was successfully included in the Interior-Environment bill that passed the House, and currently awaits Senate consideration. I will continue to monitor all developments closely, including independent Senate consideration or any conference negotiations.

Additionally, at the Legislative Committee meeting last month, I was asked to provide a summary of the federal funding in the FY24 cycle that will benefit Monterey county residents, as well as a status update on FY25 earmarks that may potentially benefit residents pending the outcome of FY25 appropriations. I have provided that information below for FY24, and for FY25 based on the House bills that have either passed the chamber or been approved by the House Committee on Appropriations, and/or been approved by the Senate Committee on Appropriations. Projects submitted or awarded to the County of Monterey are designated by the asterisk.

## 4. <u>Federal Advocacy</u>

a. Department of Transportation's Nationally Significant Federal Lands and Tribal Project (NSFLTP) Program for the Palo Colorado Road Storm Damage Repair Project

I'd like to take this opportunity to provide an update on federal advocacy efforts relating to the Palo Colorado Road Strom Damage Repair Project. Since we last addressed this topic during the June Legislative Committee meeting, the Director of Public Works, Facilities, and

Parks (PWFP) and I have continued to engage with the Department of Transportation, the National Park Service and Rep. Panetta's office. The Director of PWFP has determined that it is prudent for the County to move forward with applying for a federal grant under the Nationally Significant Federal Lands and Tribal Projects (NSFLTP) Program. As we discussed in June, this is a program that the County has not previously utilized, and more recently, Rep. Panetta's staff has encouraged the County to pursue this competitive grant opportunity.

According to PWFP, this project is essential for the rehabilitation and improvement of Palo Colorado Road, a crucial access route to the Los Padres National Forest containing several key recreational facilities. Monterey County PWFP is currently preparing an application to submit to the U.S. Department of Transportation's NSFLTP Program to request grant funding for this project. I have also requested letters in support of the County's application from Sen. Padilla, Sen. Butler, and Rep. Panetta.

As you know, Palo Colorado Road is approximately 8 miles in length serving as the *only* access road from the scenic Big Sur Coastline along Highway 1 to the pristine Los Padres National Forest in the Santa Lucia Mountains of Monterey County, California. Unfortunately, Palo Colorado Road has been battered by the impacts of climate change beginning in 2016 when the Soberanes Fire burned over 132,000 acres in Monterey County resulting in a Federal Disaster declaration. The fire left damage to Palo Colorado Road and burn scars in the surrounding hillsides. Winter storms in 2016 and 2017 exacerbated the roadway damage as large amounts of water inundated the burn scarred hillsides and canyons causing mudslides, slip outs, fallen trees and debris flows created a safety risk for the traveling public and resulted in road closures, emergency repairs and a second declaration of Federal Disaster. While Monterey County PWFP worked diligently with the Federal Emergency Management Agency (FEMA) to repair and rehabilitate much of the roadway, approximately 3.8 miles (from milepost 4.0 to 7.8) remain severely damaged and closed. The road is unusable to the public due to landslides, large road slip outs (1/4 lane-11/2 lane in width), and damaged and washed out culverts; local residents and visitors remain without access to vital recreational facilities and homes. Current roadway conditions also hinder emergency response.

The Palo Colorado Road Storm Damage Repair Project will rehabilitate and significantly improve safety and resilience of this key regional roadway providing access to Los Padres National Forest and regional recreation facilities. The Project will improve drainage systems, and stabilize the surrounding hillsides in effort to bolster the roadway against the escalating threats of climate change and prevent future closures. The Project will include the installation of soldier-pile walls and soil nail walls, slope stabilization, construction of drainage improvements and addition of guardrails for safety.

The closure of this portion of the road has eliminated access to important recreational areas, including the Bottchers Gap Trailhead and Campground, Skinner Ridge Trail, Little Sur Trail, Camp Pico Blanco, and Mill Creek Redwood Preserve. Investing in the repair and restoration of Palo Colorado Road will bring numerous benefits to our community. Restoring access to key recreational facilities and unimpeded access for emergency response is crucial for both local residents and visitors.

Federal Legislative Update September 3, 2024

I will continue to keep the Legislative Committee apprised of any significant developments related to the NSFLTP grant application or engagement with the federal Congressional delegation.

### 5. <u>Legislation</u>

#### a. H.R. 8575, the Michelle Alyssa Go Act (Goldman) – Recommend Support

This bill would increase the number of federal Medicaid-eligible in-patient psychiatric beds for individuals who are seeking treatment for both mental health and substance use disorders.

Under current federal law, Medicaid is prohibited from covering long-term stays for patients between the ages of 21 and 64 who are receiving mental health or substance abuse treatment in a facility with more than 16 beds, known as an Institution for Mental Diseases (IMD). The Michelle Alyssa Go Act would raise the limit for a facility to be eligible for Medicaid coverage, from 16 in-patient psychiatric beds to 36. This would more than double the beds eligible to be funded by federal Medicaid in statute. The bill also ensures these facilities meet nationally recognized, evidence-based standards of care.

H.R. 8575 seeks to ease the prohibition on Medicaid coverage, also known as the IMD exclusion that has been in effect since Medicaid was created in 1965 and has resulted in people being unable to access mental health care, as many do not have the funds to cover these services out of pocket and many institutions have downsized their capacity.

This legislation was introduced by Rep. Goldman in the House; there is not yet an identical companion bill in the Senate.
