- a. Approve and authorize the Chief Information Office to sign a non-standard Agreement with the CitySpark Incorporated for SceneThink Events Portal license for the term of October 8, 2024, through August 31, 2027, in an amount not to exceed \$10,000; and
- b. Authorize the Chief Information Officer to sign up to two (2) amendments to this agreement of one (1) year each, provided additional costs do not exceed ten percent (10%) of the prior year subject to County Counsel review and provided the terms of the agreement remain substantially the same, bringing the maximum compensation Not to Exceed amount to \$15,544.

RECOMMENDATION:

It is recommended that the Board of Supervisors:

- a. Approve and authorize the Chief Information Office to sign a non-standard Agreement with the CitySpark Incorporated for SceneThink Events Portal license for the term of October 8, 2024, through August 31, 2027, in an amount not to exceed \$10,000; and
- b. Authorize the Chief Information Officer to sign up to two (2) amendments to this agreement of one (1) year each, provided additional costs do not exceed ten percent (10%) of the prior year subject to County Counsel review and provided the terms of the agreement remain substantially the same, bringing the maximum compensation Not to Exceed amount to \$15,544.

SUMMARY:

CitySpark Incorporated will provide an online events license subscription called SceneThink Events Portal. The proposed platform will standardize a calendar of events on the County’s website.

DISCUSSION:

In March 2024, the County of Monterey Board of Supervisors approved the G-239 Web Authoring Policy which includes paragraph 3.5 County Calendar stating that “All departments are required to post public meetings to the public facing County Calendar on the main County Website, regardless of having their own procured event management solution.”

In collaboration with the County Communications Team of the County Administrative Office, ITD selected SceneThink by CitySpark Incorporated, for the County Event Calendar. SceneThink is a fully responsive and interactive platform that enables County Departments to add events to the County Event Calendar. With SceneThink, website visitors will be able to search, sort, and filter event information on the County Event Calendar.

County Counsel and the Risk Manager reviewed and approved as to non-standard insurance terms. County Counsel reviewed and approved this agreement as to legal form, and the Auditor-Controller reviewed and approved as to payment provisions.

FINANCING:

ITD has sufficient appropriations to support the FY 2024-25 cost of this Agreement within the FY 2024-25 Adopted Budget, ITD 1930, Appropriations Unit INF002. As this is an Enterprise service for all County departments, future year costs of this Agreement will be included in Enterprise costing and will be included with each department's respective fiscal year budget submission.
