WHEREAS, Susana Reyes was hired by the Monterey County District Attorney's Office as a temporary Typist Clerk I on November 24, 1980; appointed as a permanent Typist Clerk I on April 3, 1981; promoted to Typist Clerk II on May 30, 1981; promoted to Secretarial Assistant on August 20, 1983; and promoted to Legal Secretary on June 6, 1987; and

WHEREAS, Susana Reyes faithfully served in a variety of critical support roles within the Office, including the Municipal Court Desk, the Complaints Unit, the Non-Sufficient Funds Check Program, Consumer Fraud, and Witness Coordination; and

WHEREAS, Susana Reyes was promoted to Victim Assistance Advocate on December 3, 2001, marking the beginning of her distinguished service to victims of crime in Monterey County; and

WHEREAS, Susana Reyes devoted the next decade to the Special Emphasis Victim Assistance Program, providing compassionate and dedicated assistance to some of the community's most vulnerable victims, particularly those residing on the east side of Salinas, California; and

WHEREAS, Susana Reyes, in recognition of her exemplary service, received the State Department of Social Services Award in 2003; and

WHEREAS, Susana Reyes was assigned to the Underserved Victim Unit in 2011, where she provided mandated services to innocent victims of gang-related crimes throughout Monterey County; and

WHEREAS, Susana Reyes, throughout her tenure as a Victim Assistance Advocate, served an average of more than 350 victims per year and delivered in excess of 3,500 victim services annually, demonstrating exceptional professionalism, empathy, and dedication; and

WHEREAS, Susana Reyes now concludes her extraordinary career and will enjoy a well-earned retirement surrounded by her family; and
