Adopt a resolution recognizing the **10th Annual Adelante Con Orgullo Mujer Inmigrante (ACOMI) Conference**.

WHEREAS, Adelante Con Orgullo Mujer Inmigrante (ACOMI) was established in October of 2012 to support and uplift women in our community, particularly Spanish-speaking immigrant women, by fostering leadership, advancing health equity, and expanding access to opportunities that promote the well-being of themselves and their families; and

WHEREAS, in partnership with Mujeres en Acción, **Adelante Con Orgullo Mujer Inmigrante (ACOMI)** took place at Hartnell College in Salinas, CA on Saturday, February 7, 2026; and

WHEREAS, Mujeres en Acción, a Salinas-based organization that strengthens women's leadership skills, confidence, and economic opportunities, adjointly celebrated their 10 years of service; and

WHEREAS, the **Adelante Con Orgullo Mujer Inmigrante (ACOMI)** program featured community-led keynote addresses, panel discussions, and workshops that reflect a shared commitment to advancing health equity and strengthening leadership among Spanish-speaking immigrant women with workshop topics such as mental health, entrepreneurship, adult education, and access to legal services; and

WHEREAS, the 2026 conference welcomed more than 220 attendees, over 50 partner organizations, and community volunteers who dedicated their time and efforts to this event, since its inception, ACOMI has served more than 1,500 attendees over 10 Conferences; and

WHEREAS, we express our deep appreciation and gratitude to community leaders from across the county who generously volunteered their time to participate in the conference planning meetings, identified and coordinated workshop presenters, conducted outreach to promote the event, and welcomed families on the day of the conference, reflecting their commitment to their community and immigrant women's health-related needs through this conference; and

WHEREAS, we proudly recognize the **10th annual Adelante Con Orgullo Mujer Inmigrante (ACOMI) Conference** as a powerful example of collaboration that advances health equity and strengthens the leadership of Spanish-speaking immigrant women to build healthier communities.
