WHEREFORE, it is the decision of said Zoning Administrator that said application for a Use Permit be granted as shown on the attached sketch.

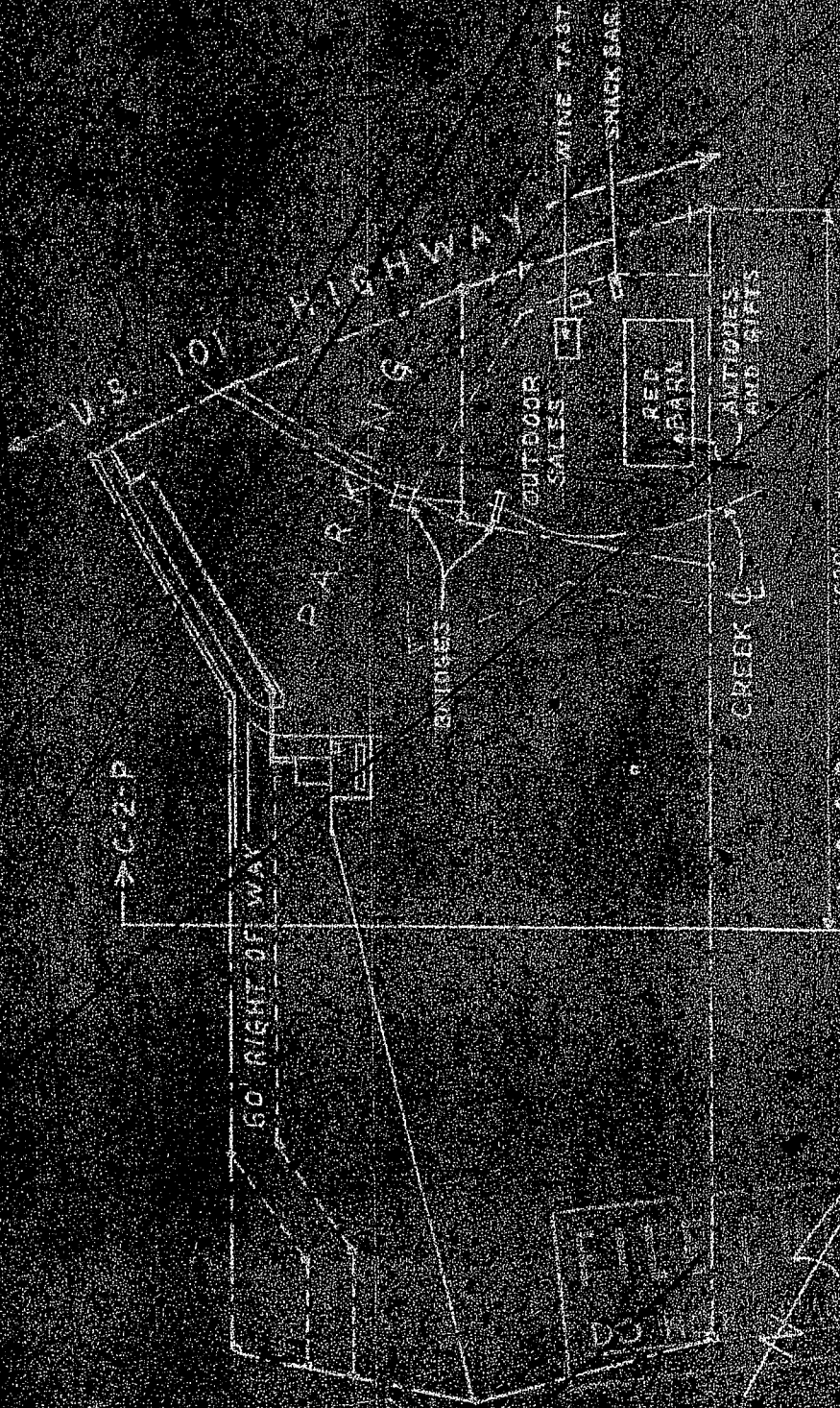

SCALE 1" = 200'

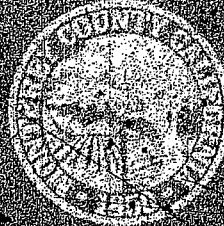

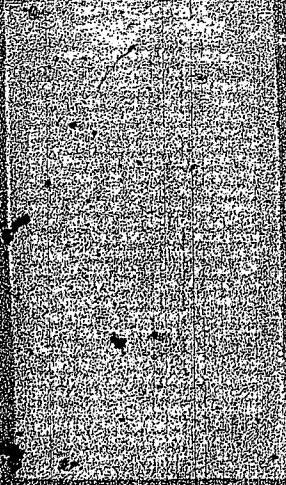
