Adopt a resolution honoring the **Rainbow Connections** in celebration of **Pride Month – June 2025**.

WHEREAS, Pride Month is celebrated annually in the month of June to honor the historic and ongoing struggle for LGBTQIA+ rights, dignity, and visibility; and

WHEREAS, the Rainbow Connections Innovations project aims to build capacity among service providers, educators, school personnel, parents, caregivers and other adults in Monterey County to understand, identify and effectively respond to the needs of LGBTQ+ youth; and

WHEREAS, the Rainbow Connection's work exemplifies the spirit of inclusion and community, providing safe spaces for youth and adults alike, hosting educational forums, cultural celebrations, and support services that uplift marginalized voices and foster belonging; and

WHEREAS, Rainbow Connections and its collaborative partners are committed to uplifting and empowering LGBTQ+ youth across Monterey County by aligning our collective forces and resources to provide opportunities for them to express their authentic selves with PRIDE, at the forefront of these partners are Partners 4 Peace, The Epicenter, Harmony at Home, The Diversity Center, DragonFly Forward and You Will Rise to name a few.
