

**AMENDMENT No. 6
TO SERVICES AGREEMENT
BETWEEN Latham & Watkins LLP, AND
NATIVIDAD MEDICAL CENTER
FOR
Consulting and Legal Services**

This Amendment No. 6 to the Services Agreement ("Agreement"), dated May 1, 2010 is entered into by and between the County of Monterey, on behalf of **Natividad Medical Center (hereinafter "NMC")**, and **Latham & Watkins LLP., (hereinafter "CONTRACTOR")**, with respect to the following:

RECITALS

WHEREAS, the Agreement was executed for CONTRACTOR to provide Consulting and Legal Services for NMC's Administrations Division with a one year term and a total Agreement amount not to exceed \$100,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on January 11, 2011 via Amendment No. 1 to add an additional \$300,000, thereby increasing the total agreement amount to \$400,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement effective July 1, 2011, via Renewal and Amendment No.2 to extend the term for an additional one year period through June 30, 2012 and to add an additional \$600,000, thereby increasing the total agreement amount to \$1,000,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement effective July 1, 2012, via Amendment No.3 to extend the term for an additional one year period through June 30, 2013 and ;

WHEREAS, NMC and CONTRACTOR amended the Agreement, effective July 1, 2013, via Renewal and Amendment No.4 to extend the term for an additional two (2) year period through June 30, 2015 and to add an additional \$500,000, thereby increasing the total agreement amount to \$1,500,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement, effective June 23, 2015, via Amendment No. 5 to extend the term for an additional three (3) year period through June 30, 2018 with no increase to the total agreement amount.

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement, effective July 1, 2018 via Amendment No. 6 to extend it for an additional three (3) year period (July 1, 2018 through June 30, 2021) for a revised full term of May 1, 2010 through June 30, 2021, and to add \$10,000 for a revised total agreement amount not to exceed \$1,510,000.

AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

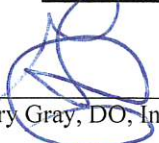
1. Section 6 of the original agreement "**RATES FEES AND CHARGES**" paragraph four, shall be amended by removing, "**The maximum amount of the County's liability over the full term of this agreement (No. A-11791) is \$1,500,000 for the full term of the Agreement**" and replacing with "**The maximum amount of the County's liability over the full term of this agreement (No. A-11791) is \$1,510,000 for the revised full term of the Agreement.**"
2. Paragraph 4, Section 6, Rates, Fees and Charges "**TERM OF AGREEMENT**", first sentence shall be amended to the following; "***The term of this Agreement is May 1, 2010 through June 30, 2021 unless sooner terminated pursuant to this Agreement***".
3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 6 and shall continue in full force and effect.

4. A copy of this Amendment No. 6 Shall be attached to the Agreement.

5. The effective date of this Amendment is July 1, 2018.

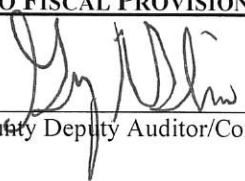

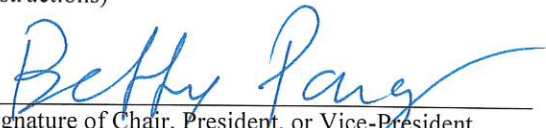
