

**RENEWAL AND AMENDMENT NO. 1
TO THE SERVICES AGREEMENT BETWEEN
BIG INVENTORY, INC. AND
NATIVIDAD MEDICAL CENTER
FOR
PHYSICAL INVENTORY SERVICES**

This Renewal and Amendment No. 1 to the County of Monterey, Natividad Medical Center (NMC) Agreement for Services is made and entered into, by and between the County of Monterey (hereinafter "County"), a political subdivision of the State of California, on behalf of Natividad Medical Center, an acute care hospital (hereinafter, "NMC"), and BIG Inventory, Inc. (hereinafter "CONTRACTOR"); (collectively, the County, NMC and CONTRACTOR are referred to as the "Parties").

RECITALS

WHEREAS, the County of Monterey on behalf of Natividad Medical Center and BIG Inventory, Inc. had previously entered into an Agreement for Services (hereinafter "Agreement") on May 1, 2019 to provide physical inventory services to NMC with a one (1) year term from May 1, 2019 through April 30, 2020, and a total Agreement amount not to exceed \$25,000; and

WHEREAS, the Agreement expired by its own terms on April 30, 2020; and

WHEREAS, the Parties wish to renew and amend the Agreement on the same or similar terms, beginning May 1, 2020 for an additional one (1) year period through April 30, 2021 to allow for services to continue, with a \$25,000 increase, for a total Agreement amount of \$50,000.

AGREEMENT

NOW THEREFORE, the Parties agree as follows:

The Agreement is hereby renewed and amended on the terms and conditions as set forth in the original Agreement incorporated herein by this reference, except as specifically set forth below.

1. Paragraph titled, "PAYMENTS BY NMC" second sentence shall be amended to the following:
"The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$50,000."
2. The first sentence of Paragraph titled, "TERM OF AGREEMENT" shall be amended to the following:
"The term of this Agreement is from May 1, 2019 through April 30, 2021 unless sooner terminated pursuant to the terms of this Agreement."
3. If there is any conflict or inconsistency between the provisions of Agreement, or this Renewal and Amendment No. 1, the provisions of this Renewal and Amendment No. 1 shall govern.
4. This Renewal and Amendment is effective when signed by both parties.

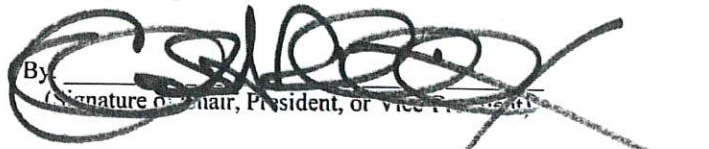
