Adopt a resolution recognizing the **Gonzales High School Girls' Soccer Team** for their outstanding achievements as back-to-back Pacific Coast Athletic League Cypress Division Champions and for advancing to the Central.

WHEREAS, the **Gonzales High School Girls' Soccer Team**, known as the Lady Spartans, had an exceptional 2024–2025 and 2025–2026 season, earning the Pacific Coast Athletic League Cypress Division Championship in consecutive years and demonstrating remarkable determination and teamwork; and

WHEREAS, during the 2024–2025 season, the team captured the program's first league championship in fifteen years, marking a historic milestone for Gonzales High School athletics; and

WHEREAS, building on that success, the team continued their strong performance during the 2025–2026 season, once again earning the Pacific Coast Athletic League Cypress Division Championship and advancing to compete in the Central Coast Section playoffs for the first time in sixteen years; and
