Amendment #1 to Agreement # A-14707

Community Networks Corporation dba Community Software Group

This Amendment #1 is made and entered into by and between the County of Monterey, a political subdivision of the State of California, (hereinafter “County”), and Community Networks Corporation dba Community Software Group (hereinafter “CONTRACTOR”).

WHEREAS, County and CONTRACTOR entered into Agreement #A-14707 for website maintenance services with a term of April 29, 2020 through April 28, 2021 for a total not to exceed amount of \$22,414 (hereinafter “Original Agreement”).

WHEREAS, The parties currently wish to amend the Agreement by **extending the term through April 30, 2023** and **adding \$43,720** for a total not to exceed amount of **\$66,134**.

AGREEMENT

Now Therefore, the parties agree to amend the Agreement as follows:

This Agreement is hereby amended on the terms and conditions as set forth in the original Agreement and in Amendment #1 incorporated herein by this reference, except as specifically set forth below.

1. **Page 9, #28, “Term of Agreement”, the first sentence is amended to read as follows: The term of this agreement shall commence as of the Effective Date hereof and shall continue through April 30 2023.**
2. Pages 13, Section 5.2 and 14, Section 6.1 identify the annual subscription fee and the rate for additional training. The total contract amount for the term April 29, 2020 through April 28, 2021 is \$22,414. This amendment adds **\$43,720** for subscription fees for the additional two-year period through April 30, 2023 for a total contract amount of **\$66,134**.
3. Except as provided herein, all remaining terms, conditions and provisions of the original Agreement are unchanged and unaffected by this Amendment #1 and shall continue in full force and effect as set forth in the original Agreement.
4. A copy of this Amendment #1 shall be attached to the Original Agreement.
