Adopt a resolution recognizing **Randy “Savage” Villalobos**, International PAL Boxing Champion, for making history for Greenfield, California, and for bringing pride to the communities of South Monterey County.

WHEREAS, Randy Villalobos began his boxing journey three years ago, training out of a garage before advancing to compete in tournaments at the local, regional, and national levels across the country; and

WHEREAS, in 2024, Randy Villalobos earned a major victory at the Gene Lewis Invitational Tournament in Mesa, Arizona, demonstrating his heart, determination, and dedication to his sport, inspiring countless youth throughout Monterey County; and

WHEREAS, Randy Villalobos trains under Coach Rigo Avila through Avila Victory Boxing, a local 501(c)(3) nonprofit organization that serves as an outreach program for youth; and

WHEREAS in the last three years, the organization has produced a National Silver Gloves silver medalist, a National Open Champion, and now, an International PAL Boxing Champion in **Randy Villalobos**; and

WHEREAS, Randy Villalobos exemplifies discipline, perseverance, and academic excellence, maintaining straight A’s, earning placement on the Principal’s Honor Roll, and participating in both the Chess Club and Leadership Class; and

WHEREAS, Randy Villalobos’ success is supported by the unwavering love and encouragement of his parents, Inez Tellez and Jaime Villalobos, his younger brother, Adriel Villalobos, and the entire Avila Victory Boxing coaching team and staff; and

WHEREAS, with only twenty-nine fights to his name, Randy Villalobos has already captured the attention of boxing competitors statewide while bringing pride and excitement to his hometown of Greenfield and the greater Salinas Valley; and

WHEREAS, Randy Villalobos continues to set a powerful example for young people throughout South County, proving that hard work, faith, and focus can turn dreams into reality and, in his words, “changing our community, one punch at a time.”
