# Williamson Act Protects Ag

The California Land Conservation Act of 1965 — allows local governments to establish contracts with landlords for the purpose of restricting parcels for agricultural use.



# New Contracts would take effect January 1, 2024

## Two (2) Programs:

- ✓ Agricultural Preserves (AgP)
- ✓ Farmland Security Zones [FSZ- (aka “Super Williamson Act”)]

## Shared Qualifications for both Programs:

- ✓ Min. Acreage: 100 or more acres. Can be less than 100 acres, but 40 or more
- ✓ History of primary agricultural use 3 of 5 years
- ✓ Min. Income: \$8,000
- ✓ Consistent with County’s General Plan
- ✓ If within 1 mile of a city, notify the city to allow them the right to protest

## Farmland Security Zone Applications:

- ✓ Land comprised of at least 51% of “predominantly prime” farmland which includes Prime, Farmland of Statewide Significance, Unique and Farmland of Local Importance
- ✓ Greater tax benefit
- ✓ If in Sphere of Influence of a City, City must by Resolution approve the FSZ application



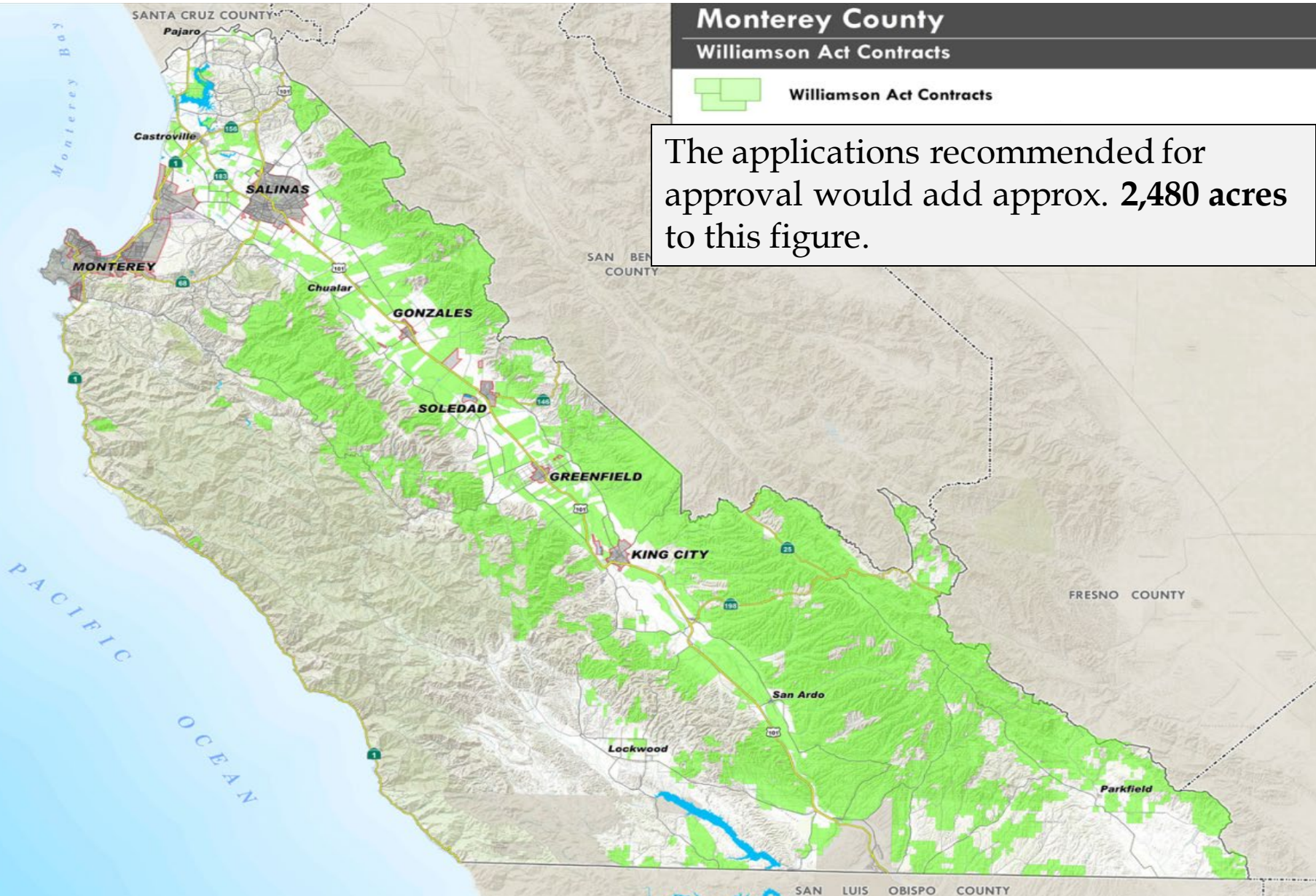
# Existing Land under Contracts in Monterey County: 802,282 acres

The applications recommended for approval would add approx. **2,480 acres** to this figure.



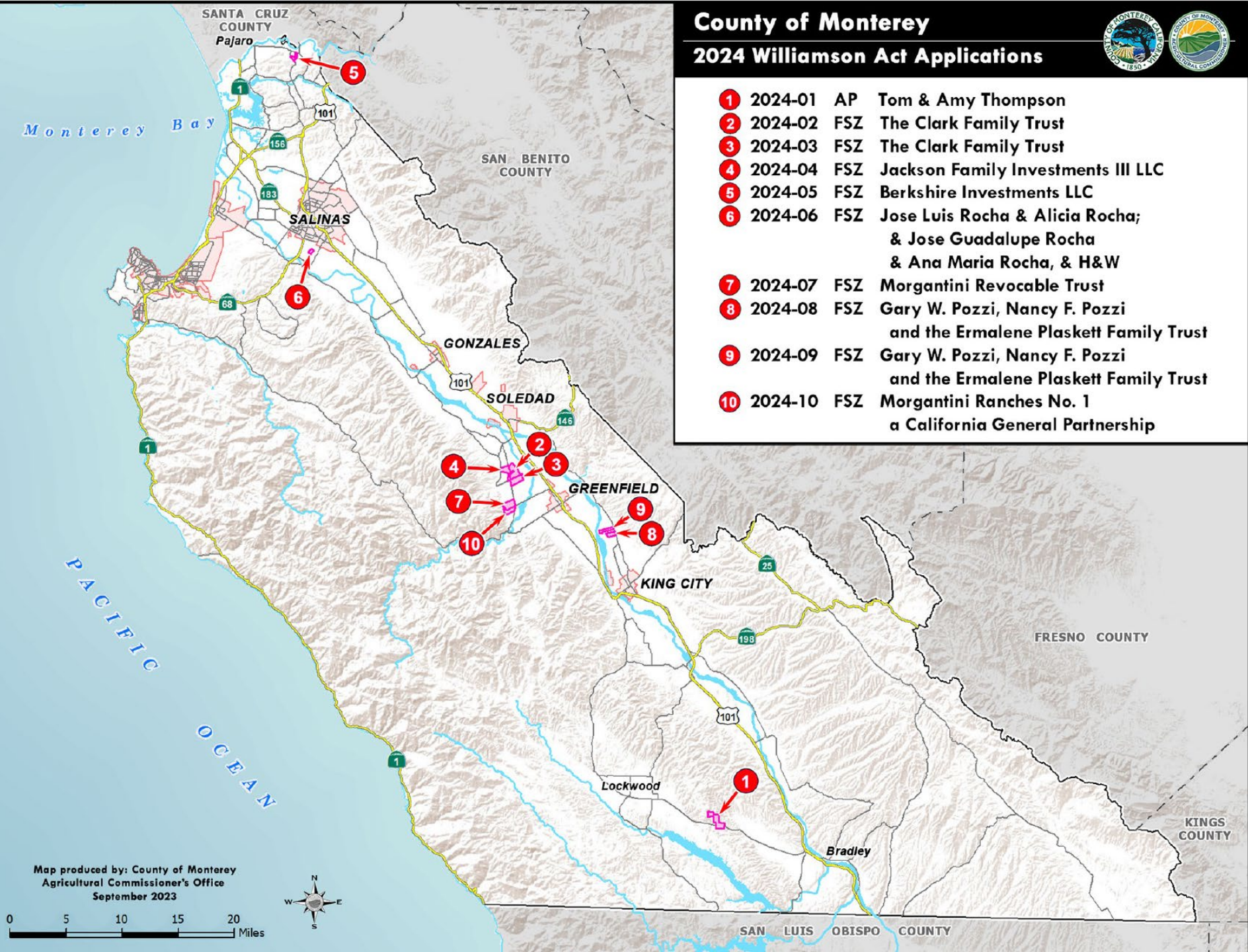

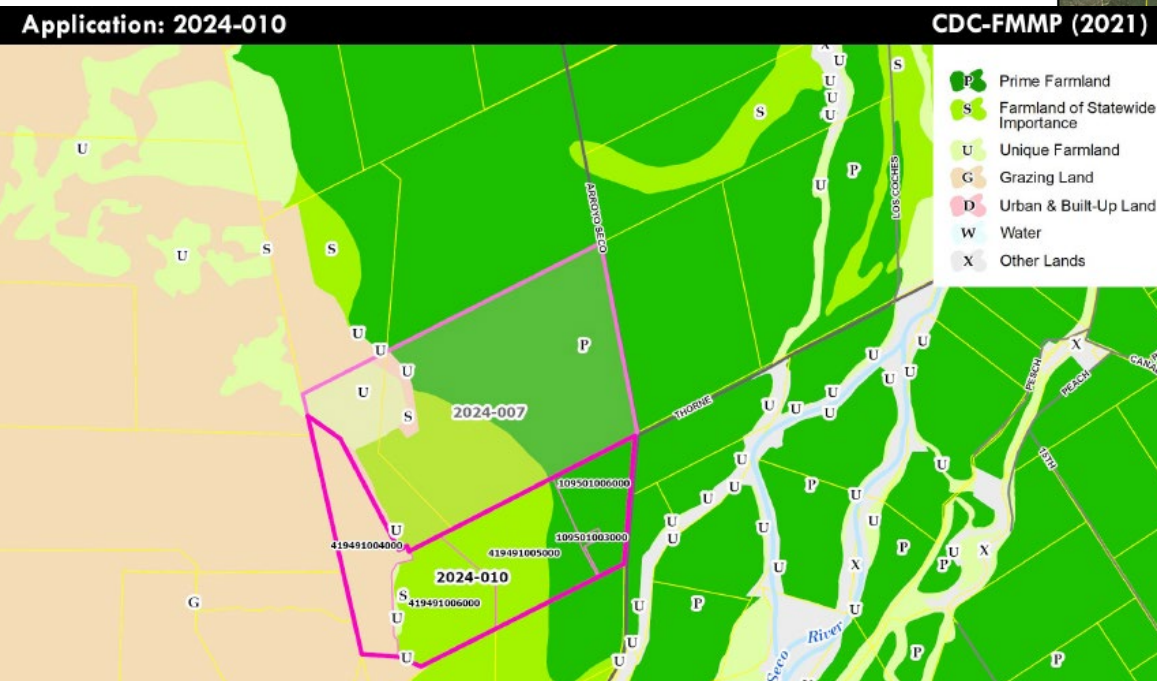
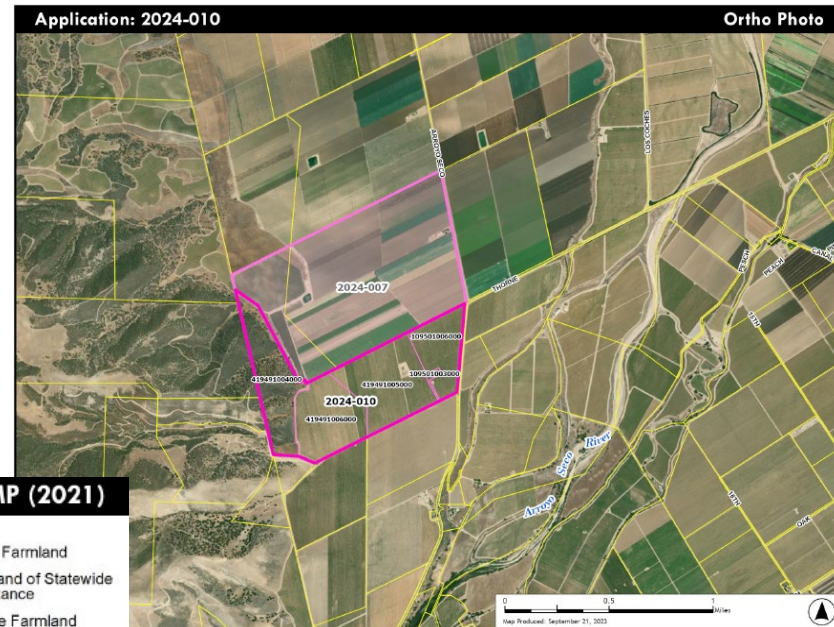

## Partial Approval of No. 2024-10 Morgantini (FSZ)

- 41650 Arroyo Seco Rd, Greenfield
- Application includes 5 APNs totaling 289 acres
- 2 of 5 APNs not recommended to be part of the FSZ:
  - ✓ APN: 419-491-004
    - 73 acres of "Grazing Land"-AgP No. 68-082
  - ✓ APN: 109-501-003 (10,000 sq. ft. well lot)



APRC Recommends Approval of 215 acres (3 out of 5 parcels) designated *Prime Farmlands* and *Farmland of Statewide Importance*
