

**AMENDMENT No.2 TO AGREEMENT BY AND BETWEEN
COUNTY OF MONTEREY AND K&H PRINTERS-LITHOGRAPHERS INC.**

THIS AMENDMENT is made to the AGREEMENT for official ballot printing and mailing services by and between **K&H PRINTERS-LITHOGRAPHERS INC.**, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and CONTRACTOR entered into an AGREEMENT for the CONTRACTOR to provide County with official ballot printing and mailing services with a term of 11/5/2019 to 9/30/2023 and total aggregate not to exceed amount of \$6,000,000; and,

WHEREAS, the County and CONTRACTOR amended the Agreement to extend the term two (2) additional years through September 30, 2025 and increase the amount by \$3,600,000 for a total amount not to exceed of \$9,600,000;

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to extend the term two (2) additional years through September 30, 2027 and increase the amount of the Agreement by \$3,800,000 due to the term extension, for a total not to exceed amount of \$13,400,000 to allow CONTRACTOR to continue to provide services.

NOW THEREFORE, County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Section 2., "PAYMENTS BY THE COUNTY" shall be amended to the following: "The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$9,600,000" and replacing it with "The total amount payable by County to CONTRACTOR under this AGREEMENT shall not exceed \$13,400,000."
2. Paragraph 3, "TERM OF AGREEMENT", shall be amended by removing, "The term of this Agreement is from 11/5/2019 to 9/30/2025 unless sooner terminated pursuant to the terms of this Agreement", and replacing it with "The term of this Agreement is 11/5/2019 to 9/30/2027 unless sooner terminated pursuant to the terms of this Agreement".
3. EXHIBIT B – PRICING SCHEDULE shall be amended by adding several additional services as per EXHIBIT B1 Revised-PRICING SCHEDULE per AMENDMENT attached hereto.
4. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
5. A copy of this AMENDMENT shall be attached to the original AGREEMENT dated December 5, 2019.
