Administrative hearing to consider replanting of one Monterey Pine tree, restoration of slopes in excess of 25%, and construction of a 270 linear foot concrete wall to partially clear Code Enforcement Case No. 24CE00444.

### RECOMMENDATIONS

It is recommended that the County of Monterey Chief of Planning adopt a resolution to:

- a. Find that minor restoration qualifies for a Class 33 Categorical Exemption pursuant to CEQA Guidelines section 15333 and there are no exceptions per Section 15300.2; and
- b. Approve a Restoration Permit and an after-the-fact Design Approval to allow replanting of one Monterey Pine tree, restoration of slopes in excess of 25%, and construction of 270 linear foot concrete fence to partially clear Code Enforcement Case No. 24CE00444.

The attached draft resolution includes findings and evidence for consideration (**Exhibit A**). Staff recommends approval subject to 5 conditions of approval.

## **SUMMARY**

Staff is recommending approval of a Restoration Permit and After-the-fact Design Approval subject to the findings and evidence in the attached Resolution (see **Exhibit A**), and subject to the conditions of approval attached to the Resolution. The deadline for submittal of written comments in opposition to the project, its findings, or conditions, based on a substantive issue, is 5:00 p.m. on Tuesday, May 6, 2025. The permit will be administratively approved the following day if we do not receive any written comments by the deadline. You will receive a copy of your approved permit in the mail. We will notify you as soon as possible in the event that we receive correspondence in opposition to your project or if the application is referred to a public hearing.

Note: This project will be referred to the Monterey County Zoning Administrator if a public hearing is necessary. The decision on this project is appealable to the Board of Supervisors and the California Coastal Commission.
